# **Boeing 767 Cargo Jet crashes near Anahuac**

# Search difficult in muddy marsh

ANAHUAC – This quiet suburban community was the scene of a horrific airplane accident last Saturday afternoon, as a Boeing 767 jumbo jet dropped from the sky into Jack's Pocket, a backwater of Trinity Bay.

The flight was Atlas Air 3591, a cargo plane carrying packages for Amazon on a trip from Miami to

At about 12:40 pm, authorities said it fell from 6300 feet into the bay, at an angle almost straight down. A witness said she saw it dive, roll to the left, and catch it's wing as it landed in the marsh and water of the bay.

First responders included the Chambers County Sheriff, Brian Hawthorne, and fire and EMS from nearby Anahuac. Later authorities included DPS,



AUTHORITIES can only use airboats to search for debris, black box recorders, and bodies of the three airman, due to the muddy marsh and shallow water. Only small fragments were left of the jumbo jet, after nosediving into Trinity Bay.

Coast Guard, Houston Police and dive team, Harris County Sheriff, Texas Parks and Wildlife, and Baytown divers The FAA and the NTSB will be in charge of the investigation. At this time, there is no known cause for the crash. and air traffic controllers said there was no distress

call or radio indication of a problem.

The plane broke into hundreds of small pieces, either in the air or as it hit the water. There were three crewmen aboard, and the bodies of two have been recovered.

Authorities are searching for the Black Box controllers, apparently silent due to the muddy marsh where they are embedded, along with many of the parts of the plane. The search is urgent, because the 767 is considered one of the safest planes flying, and authorities want to know what caused this

### Babin Statement on Cargo Jet Crash Near Baytown:

I was saddened to learn of the cargo jet crash Saturday afternoon in our Congressional district outside Baytown. I express my sincerest condolences to the families of those who lost their lives

We should be thankful for the local and federal officials who rushed to the scene and will continue working in the coming days and weeks to assist at the crash site.

The National Transportation Safety Board (NTSB) is leading an investigation into the crash, and my office and I will re-NTSB and other authorities as we seek the cause of this crash and work to prevent similar tragedies in the future."

# SENATE BILL WOULD *RAISE PAY FOR ALL* **TEACHERS**

(Austin) Every public school teacher in Texas would get a five thousand dollar raise in annual pay starting in the 2019-2020 school vear under a bill approved by the Senate Finance Committee Monday. Committee Chair and bill author Senator Jane Nelson of Flower Mound said that Texas teachers haven't seen a significant pay raise in 20 years, while the cost of living continues to rise "We need to provide this salary in order to retain our teachers in our classrooms, and to attract new teachers to the profession," she said. "We've got to make sure we attract the best and the brightest, and we've got to keep them." The commitany urban school district. The Texas Commission on School Finance, an interim study group formed to make recommendations for sweeping education finance reforms, found that the single greatest inschool factor for student achievement is teacher quality. The findings from that interim study will likely be central to any education finance reform package considered in both chambers. Senate Education Committee Chair and Finance member Senator Larry Taylor, who is currently working to craft the Senate's version of education reform legislation, told members that the bill complements the teacher compensation reforms envisioned in that

budget has \$3.7 billion set aside to pay for the salary increase, but that price tag will go up a little more after it was changed to ensure the state covers increased pension costs Because teacher retirement benefits are based on an average of the five highest-paid years in an educator's career, a statewide increase like the one proposed would increase the total cost of teacher pensions by about \$240 million per year over the next two years. Another amendment added by the committee seeks to ensure the raises are permanent. Nelson said she can guarantee that she'll fight to maintain the raise as long as she's in office, and that any future legislatures would have to make a proactive decision to remove it from statute. "If this passes it will be an established fund and if somebody's going to change it, they're going to have to go back and revoke what we're doing here today," she said.

With 22 of 31 Senators signed on as co-authors of the bill as of Monday afternoon, SB 3 should have a clear path out of the Senate. Whether or not members of the House support such a measure. or one that blends approaches, will remain to be seen.

# Caucus names legislative priorities for public education

AUSTIN — The Texas House Democratic Caucus on Feb. 21 announced its "Texas Kids First" education-funding package that would include all-day prekindergarten, teacher rais-es and retirement and

property tax reform.
"We hope to work with our colleagues to incorporate some of these ideas into their bills," said Rep. Chris Turner, D-Grand

Prairie, caucus chair. Caucus member Rep. Gina Hinojosa, D-Austin, a former Austin Independent School District board president, said Texas rates 42nd in the nation in per-student funding. She said Texas public school students are funded \$2,300 per year below the national average.

The proposed funding package is embodied in several bills that caucus members have filed or are in the process of filing, and would add some \$14.5 bil lion more in baseline budget estimates. Items to be covered include: Teacher pay and bene-

fits increases; - Incentives for educat-

ing low-income students, children speaking little or no English, and specialneeds pupils;
- Funding for the hiring

of more counselors;
- Using money from the

Rainy Day Fund for retired teachers;

- A monthly state contri-bution of \$100 toward teachers' health care premiums: and

- A one-time \$500 teacher reimbursement for outof-pocket school supply purchases.

### Defendants settle with state

Texas Attorney Gener al Ken Paxton on Feb. 19 announced that Xerox Corporation and several of its former subsidiaries, including Conduent Inc., agreed to a \$235.9 million settlement with the State of Texas.
The settlement re-

solves a lawsuit brought by Paxton's office under the Texas Medicaid Fraud Prevention Act and other grounds regarding the processing of prior-authorization requests by dentists to deliver orthodontic services to Medicaid pa-tients. Xerox and its companies, Paxton said, were responsible for reviewing and approving or denying requests by Medicaid providers to deliver orthodontic services between January 2004 and March

Paxton's office determined that employees of Xerox, Conduent and re-lated companies rubberstamped orthodontic prior-authorization requests without assuring the required review of each request by qualified clinical personnel. As a result, expensive, taxpay-er-funded orthodontic work was performed on thousands of children who either didn't meet the Medicaid standard for braces or didn't require treatment. The Medicaid program does not pay for braces for cosmetic purposes. Under Texas law, only those requests that meet strict Medicaid program requirements are allowable

# Oil & gas boom to

continue Commissioners Ryan Sitton, Christi Craddick and Wayne Christian of the Texas Railroad Commission on Feb. 20 told the state Senate Committee on Natural Resources & Economic Development that discoveries of massive energy reserves in West Texas would enhance the state's booming

energy industry.
Christian said the reserve found in the Wolf-camp Shale and Bone Spring Formation in West Texas is estimated to contain more than 46 billion barrels of oil and 281 trillion cubic feet of natural gas, enough to support decades of production at current levels.

Craddick told the panel that in 2017, the Legislature set a target for the Railroad Commission to plug 1,900 "orphan" wells in the 2018-2019 biennium. She estimated that the commission would cap more than 3,000 such wells by the end of 2019.

Sitton said the demand for the Railroad Commission to plug non-producing wells is also going to increase as the industry grows, and for that, the agency is requesting \$39.1 million in 2020-2021 to support the well-plugging pro-



This is an opportunity for Harris County to lead other agencies in Texas, should it decide to provide family leave beyond what is available to an employee through earned paid sick and vacation leave days.

Expanding paid family leave ensures our families get the time they need to take care of their loved ones," said Commissioner Adrian Garcia

If approved, this would be the first time Harris County has implemented this type of paid family leave.

The facility's compliance file, if any exists, is available for public review in the Houston regional office of the TCEQ.

The executive director has determined the application is administratively complete and will conduct a technical review of the application. Information in the application indicates that this permit renewal would not result in an increase in allowable emissions and would not result in the emission of an air contaminant not previously emitted. The TCEQ may act on this application without seeking further public comment or providing an opportunity for a contested case hearing if certain criteria are met.

PUBLIC COMMENT You may submit public comments, or a request for a contested case hearing to the Office of the Chief Clerk at the address below. The TCEQ will consider all public comments in developing a final decision on the application. The deadline to submit public comments is 15 days after newspaper notice is published. After the deadline for public comments, the executive director will prepare a response to all relevant and material, or significant public comments. Issues such as property values, noise, traffic safety, and zoning are outside of the TCEQ's jurisdiction to address in the permit process.

After the technical review is complete the executive director will consider the comments and prepare a response to all relevant and material, or significant public comments. If only comments are received, the response to comments, along with the executive director's decision on the application, will then be mailed to everyone who submitted public comments or who is on the mailing list for this application, unless the application is directly referred to a contested case hearing.

OPPORTUNITY FOR A CONTESTED CASE HEARING You may request a contested case hearing. The applicant or the executive director may also request that the application be directly referred to a contested case hearing after technical review of the application. A contested case hearing is a legal proceeding similar to a civil trial in state district court. Unless a written request for a contested case hearing is filed within 15 days from this notice, the executive director may act on the application. If no hearing request is received within this 15 day period, no further opportunity for hearing will be provided. According to the Texas Clean Air Act § 382.056(o) a contested case hearing may only be granted if the applicant's compliance history is in the lowest classification under applicable compliance history requirements and if the hearing request is based on disputed issues of fact that are relevant and material to the Commission's decision on the application. Further, the Commission may only grant a hearing on those issues submitted during the public comment period and not withdrawn.

A person who may be affected by emissions of air contaminants from the facility is entitled to request a hearing. If requesting a contested case hearing, you must submit the following: (1) your name (or for a group or association, an official representative), mailing address, daytime phone number; (2) applicant's name and permit number; (3) the statement "[I/we] request a contested case hearing;" (4) a specific description of how you would be adversely affected by the application and air emissions from the facility in a way not common to the general public; (5) the location and distance of your property relative to the facility; (6) a description of how you use the property which may be impacted by the facility; and (7) a list of all disputed issues of fact that you submit during the comment period. If the request is made by a group or association, one or more members who have standing to request a hearing must be identified by name and physical address. The interests the group or association seeks to protect must also be identified. You may also submit your proposed adjustments to the application/permit which would satisfy your concerns. Requests for a contested case hearing must be submitted in writing within 15 days following this notice to the Office of the Chief Clerk at the address below.

If any requests for a contested case hearing are timely filed, the Executive Director will forward the application and any requests for a contested case hearing to the Commissioners for their consideration at a scheduled Commission meeting. Unless the application is directly referred to a contested case hearing, the executive director will mail the response to comments along with notification of Commission meeting to everyone who submitted comments or is on the mailing list for this application. The Commission may only grant a request for a contested case hearing on issues the requestor submitted in their timely comments that were not subsequently withdrawn. If a hearing is granted, the subject of a hearing will be limited to disputed issues of fact or mixed questions of fact and law relating to relevant and material air quality concerns submitted during the comment period.
