Divers recover body of driver of semi that plunged off I-10 into the River

EAST HARRIS COUNTY – For the third time in the last two months, a vehicle has plunged over the side of a highway bridge, and the occupant was killed.

The most recent event occured Wednesday, July 3 on the I-610 East Loop bridge over the Houston Ship Channel. Authorities reported that an 18-wheelswerved to miss a car that had cut in front of him, and crashed through the railing and fell 150 to land on the buildings below. Emergency responders attempted to remove the driver from the wreckage, but he was pinned upside down and died at the scene. The driver of the truck was not immediately identified. His rig land-

ed on top of some industrial buildings of Huntsman Chemical Company. They said that no plant employees were injured, but that operations were stopped due to a sanitary sewer line that was severed and leaking. Some traffic lanes on the bridge were closed, as TxDOT studied how to repair the railing.

This fatal accident followed by only a week a similar accident on the I-10 bridge over the San Jacinto River, when an 18-wheeler struck a stopped car and then plummeted over the rail and into the river.

In this accident, a sedan driven by two young men had stopped in the west-

Local water bills are increasing

NORTHEAST HARRIS COUNTY – San Jacinto River Authority (SJRA) is increasing groundwater and surface water rates, according to its press release.

It is the first time in 16 years that it is increased and over a decade since the Texas Legislature enacted the 3-2-1 Act that relates to subsidence and using thee tons to one of surface water to subsurface water.

The wholesale water sales entity with a facility in Highlands attributes some of the increase to groundwater conservation rules from the Lone Star Groundwater Conservation District (in Montgomery County) (LSGCD) not being clearly defined. Uncollected funds and to finance a new surface water treatment plant are other factors for increase noted in the press release.

The rate adjustment is after the Texas Water Development Board voted down a LSGCD's proposed groundwater management plan for Montgomery County back in May, requiring the LSGCD to submit a new management plan and standards.

Last month water rates increased slightly in Crosby Municipal Utility District and just about all other water sellers with notation that the increase must be funded for Crosby to continue purchasing the water

The subsurface rate jumped from \$2.64 per 1,000 gallons to \$2.73 per 1,000 gallons. Surface water increased from \$2.83 per 1,000 gallons to \$3.15 per 1,000 gallons.

The rate adjustment applies to all utilities participating in the SJRA's Groundwater Reduction Plan (GRP.)

"The GRP water plant was built to satisfy requirements that we develop a plan to use less groundwater," SJRA General Manager Jace Houston said in the release. "Utilities throughout the Greater Houston region have been working to achieve stable, reliable groundwater levels for almost 50 years. We expect Lone Star Groundwater Conservation District to work with all utilities in Montgomery County on a way to manage groundwater responsibly instead of changing their requirements and creating risks and uncertainty. Changing the rules is costly for utilities, cities and MUDs. Ultimately everyone's water bills go up, not down."

Outing turns deadly in Huffman

HUFFMAN – From wheeling about the San Jacinto River to an apparent murder-suicide is a tragic turn for two neighbors and friends here June 30.

Two men were dead after an argument around 3:00 a.m. according to deputies called to Ideloch Subdivision concerning a shooting in progress.

When deputies arrived they found

When deputies arrived they found Austin Smith, 27, lying in his driveway, dead of an apparent gunshot wound. His pickup and an ATV were parked at the end of his driveway.

Witness testimony indicated that Smith and his girlfriend had gone with neighbor, Coby Rigsby, 32, and his girlfriend "Mudding" in their trucks and off-road vehicles. Statements indicate an argument

between Rigsby and his girlfriend became heated and was interrupted by Smith but that Rigsby took offense at Smith's interdiction and a fight began between the two men in Rigsby's lawn.

According to statements, Rigsby produced a pistol and all three of the others, both girlfriends and Smith left the

Boat crashes into bulkhead, one dead

CHANNELVIEW — Authorities were able to end their search for a missing boater Tuesday morning, when they discovered the body of a man thought to be Luis Gonzalez, 33.

Sunday night about 7:30 pm a motorboat travelling at a high rate of speed on the San Jacinto River, near Rio Villa, crashed into a bulkhead, crumpling the boat and seriously injuring two people on the boat, with the third person thrown overboard and declared missing.

Authorities reported that Galan Ruiz was transported by Life-Flight to a hospital with severe leg injuries, and Michelle Huff was transported to a hospital with lacerations, a broken log and inter

leg, and internal injuries.
Sheriff's Deputies and Texas Parks and Wildlife deputies said that the boat had a number

of beer cans inside and nearby in the water. Ruiz had a blood alcohol content of .093 and was the operator of the boat. He was allegedly drunk, and has now been charged with felony murder.

Pro-Life Bills Passed into Law

Harris County Attorney Ryan opposes EPA emissions "loophole"

Friday, June 28, 2019 - Harris County Attorney Vince Ryan today filed a formal letter of opposition to a proposed Environmental Protection Agency rule that would allow companies in Texas to avoid civil penalties for polluting the air during so-called Startup Shutdown, or Maintenance (SSM) activities.

Ryan is objecting to an EPA proposal to withdraw a 2015 finding that Texas's plan did not comply with the federal Clean Air Act because of state rules that provide companies with an affirmative defense for excess air emissions that occur during SSM events.

"Texas's regulations have a loophole through which facilities can exceed permit emissions limits during upsets and unplanned SSM events without fear of being held fully accountable under the law," said County Attorney Ryan.

"This loophole not only harms nearby communities but also endangers first responders, including County employees, who respond to SSM events," he said.

In his letter to the EPA, County Attorney Ryan laid out facts that led to his opposition:

Houston has some of the worst air in the nation and the eight county nonattainment area consistently fails to meet federal health based

Communities around facilities with SSM events in Harris County are primarily low income, low resource, linguistically isolated communities of color and are especially impacted by these events.

The EPA is legally required by the Clean Air Act to close this loophole and correctly required Texas to do so in 2015.

Ryan also points out that the community impact of these SSM events continues to linger, as residents impacted by these pollutants released into the air often have to shoulder the cost of medical care, compounded by the strain of missed days at work and school. Instead of affirmative defenses, Ryan believes polluters should face full enforcement under the environmental laws



"I urge EPA not to finalize its proposed rule and instead withdraw the proposal," said County Attorney Ryan. "SSM events have real adverse health impacts on communities around industrial facilities and allowing them to occur without penalty will only prolong and exacerbate those impacts.

Prominent local legislators named to important redistricting panel

Lieutenant members to redistricting panel

AUSTIN — Lt. Gov Dan Patrick on June 28 released the names of his appointees to the Γexas Legislature's 2021 Redistricting Committee.

Patrick, who presides over the 31member state Senate, named Sen. Joan Huffman, R-Houston, as chair of the committee, and Sen. Juan "Chuy" Hinojosa, D-McAllen, as vice chair. He also named 13 more Senate members to the committee, including Sens. Carol Alvarado, D-Houston; Paul Bettencourt, R-Houston; Dawn Buckingham, R-Lakeway; Donna Campbell, R-New Braunfels; Pete Flores, R-Pleasanton; Kelly Hancock, R-North Richland Hills; Bryan Hughes, R-Mineola; Eddie Lucio Jr., D-Brownsville: Jose Menendez, D-San Antonio; Robert Nichols, R-Jacksonville; Angela Paxton, R-McKinney; Charles Perry, R-Lubbock; Kirk Watson, D-Austin; Royce West, D-Dallas; and John Whitmire, D-Houston.

In January, Texas House Speaker Dennis Bonnen, R-Angleton, named 15 members to the House Redistricting Committee, with jurisdiction that includes preparations for the redistricting process Those members nclude: Rep. Phil King, R-Weatherford, chair; Rep. Chris Turner, D-Grand Prairie, vice chair; and Reps. Sheryl Cole, D-Austin; Matt Krause, R-Fort Worth: Lyle Larson, R-San Antonio; Jeff Leach. census. If the Legislature fails to adopt a redistricting plan by the end of the 2021 legislative session, a Legislative Redistricting Board consisting of the lieutenant governor, comptroller, House speaker, attorney general and land commissioner, shall convene within 90 days of adjournment and adopt a plan within 60 days

In addition to redrawing Texas House, Texas Senate and U.S. congressional districts, the Legislature also is required to review the 15 State Board of Education districts for any necessary redrawing of district boundaries

As Texas' bipartisan 2021 Redistricting Committee goes about its work, a U.S. Supreme Court ruling released June 25 is sure to stimulate discussion during the process

In the ruling, Chief Justice John Roberts, in writing the majority opinion, remarked that federal courts are unable to decide cases of partisan

gerrymandering. "We conclude that partisan gerrymandering claims present political questions beyond the reach of the federal courts. Federal judges have no license to reallocate political power between two major political parties, with no plausible grant of authority in the Constitution, and no legal standards to limit and direct their decisions," Roberts

So, with the U.S. Supreme Court and lower federal courts no longer the court of last resort for plaintiffs with voting rights appeals based on allegations of

partisan gerrymandering, the weight of the job of the redistricting committee

Solicitor general testifies

In other news related to redistricting and voting, Texas Solicitor General Kyle Hawkins on June 25 testified in Washington, D.C., before the U.S. House Subcommittee on the Constitution, Civil Rights and Civil Liberties.

The panel heard testimony on continuing constitutional problems with the U.S. Voting Rights Act since the U.S. Supreme Court's landmark 2013 ruling in a case alleging racial gerrymandering. The high court's ruling in the case, Shelby County (Alabama) v. Holder, struck down a provision in the act that required Texas and certain other preclearance from the U.S. Justice Department or a federal court before making changes to voting laws.

In concluding his testimony, Hawkins said, "As Congress revisits the Voting Rights Act, it must adhere to the constitutional principles the Supreme Court articulated in Shelby County that limit the power of the federal government to impede on fundamental principles of federalism and disturb the coequal sovereignty of the states.

Texas Comptroller Glenn Hegar on July 2 announced state sales tax revenue totaled \$2.86 billion in June, an amount 3.3 percent more than the amount reported for the month of June 2018.

Also, total sales tax revenue for the three months ending in June 2019 was up 5.1 percent compared to the same period a year ago. Sales tax is the largest source of state funding for the state budget, accounting for 57 percent of all tax collections, Hegar said.

Houston, TX - The

accounts and images emanating from our southern border are horrific and unbecoming of a country regarded as the last best hope of the world. Indeed, these experiences were relayed in shocking and graphic terms in a recent report of the Inspector General of the Department of Homeland Security which found that migrants are being held in dangerous conditions in overcrowded facilities. The conditions have become so dire that. according to a new report, the situation is described as a "ticking time bomb" that merits our immediate action. For example, official reports have found that 51 women were being held in a facility designed to house 40 juveniles. Meanwhile, 71 men are held in a cell designated for 41 men. Indeed certain cells are so crowded that some migrants are being forced to stand for days at a time. Some migrants are standing on toilets to secure breathing room. Meanwhile, the toll on the youngest migrants is compelling. Some children 7 and under have been in facilities for upwards of two weeks and more, and some children are forced to wear soiled clothes. Congresswoman Sheila Jackson Lee, a senior member of the House Committee on Homeland Security and a former Chair of the Border & Maritime Subcommittee will travel to these facilities on an official visit of the Homeland Security Committee to assess the situation and gather information, pursuant to her oversight responsibilities as a member of the United States Congress

YOU HAVE AN ESTATE...DO YOU HAVE A PLAN?

Many people have a will and think that their estate plans are complete. A comprehensive estate plan will include a will or trust, a financial power of attorney (commonly called a durable power of attorney) a medical power of attorney with HIPAA compliant language and a directive to physicians, commonly called a living

There are 6 common issues that may occur throughout your life that require you to update your estate plan. These issues are discussed

1) Children

If you have a child you need to update your estate plan to provide a guardian for the child. If you do not choose the guardian for your child the court will do it for you without your input! This can result in chaos for the child and everyone involved. You are the person who knows who is the best person to be the guardian for your children. You need to make

If you leave a portion of your estate to a minor child, or incapacitated child you will want to leave a trustee in charge of those funds. You can control how the beneficiary receives the property money and when, or if that beneficiary receives the property money free from trust. Do you have a spendthrift child, or spouse? If so a trust which includes management for the life of the child and then a beneficiary for the remaining funds after that child dies could resolve that problem. You would not want your child or spouse to be left to depend on the charity of others. Don't allow them to deplete their funds without regard of their future It is your money and your loved one

2) Marriage/Remarriage When you get married your estate plan will change. Prior to marriage you will probably provide for your assets to go to your parents or friends. Typically, after marriage people want their assets to go to their spouse. After you are married you need to update your estate plan to reflect this change. If you get remarried you should update your estate plan as well. Many times there are children from previous marriages and you need to choose how the assets will be divided among beneficiaries. By planning your estate it will be executed smoothly. If you do not update you estate plan the estate can be tied up in court for years. One recent case is still pending and the person died





in 1993! The parties involved are the deceased's second wife and his children from his first marriage. Prior to the division of the property the parties involved "had a great relationship." It is essential that each individual makes clear the way that ney want their assets to be divided. Protect your loved ones by setting out a plan for their future, a plan they cannot influence, or alter.

3) Increase in Wealth

Many people set up their estate plan when they are younger and have fewer assets. As they grow older their assets appreciate and they may, without even realizing it, approach the personal exemption for the estate tax. The government gives each citizen a personal exemption from the estate tax. A married couple can set up a by-pass trust and double their exemptions, thus passing twice as much to their beneficiaries free from estate tax. When calculating the estate value for estate tax purposes life insurance proceeds, retirement accounts, bank accounts, real estate, and personal property are all included. Many people believe that choosing a beneficiary for these plans or holding joint accounts excludes the asset from your estate This is incorrect. These steps may allow the asset to avoid probate, thus bypassing the beneficiary designations in your will (which may or may not be your intention). however, it will still be included in the estate for estate tax purposes. Given the appreciation of home values and retirement accounts many people are approaching the personal exemption and need to set up bypass trusts to preserve both spouses' personal exemption as well as pursue other options to avoid paying the estate tax. 4) Non-Citizen Spouse Many people do not realize that a non-citizen spouse does not receive the unlimited marital deduction that citizens enjoy. This means that if a citizen spouse passes away and the citizen spouse has assets of over the \$5,000,000 (for 2011 & 2012) personal

exemption the estate tax is due immediately. This can be burdensome since the assets may be in real estate or retirement accounts and may not be liquid. It could force liquidation of assets in ways that are not tax advantageous as well as liquidations where the market is in flux. Congress has altered the rules applicable to noncitizen spouses in the following ways (all discussed in more detail below):

The unlimited estate tax marital deduction for transfers to non-citizen surviving spouses is disallowed, unless such property is placed in a qualified domestic trust (QDOT):

The unlimited gift tax marita deduction for transfers to non-citizen spouses is disallowed, but the annual exclusion from the federal gift tax is increased:

The full value of jointly held property is included in the estate of the U.S. citizen spouse; and

In certain situations where one spouse is a non-citizen the creation or termination of a joint tenancy can create a tax problem. Any family that is approaching the personal exemption needs to address this

Additionally, a non-citizen spouse may have assets located outside the United States. It is important to carefully plan for these assets to assure that they are given to the proper beneficiaries. This planning includes coordinating United States law, the law of the foreign jurisdiction and applicable treaties between the countries.

5) Health Care Power of Attorney Executed Prior to 1996

In 1996 Congress enacted the Health Insurance Portability and Accountability Act (HIPAA). The result has been that it is much harder for other people to access your health information. Unfortunately, this has been interpreted in many different ways by different hospitals and has resulted in friends and family being denied access to their loved ones information when they are attempting to help. The easiest way to remedy this is with a health care power of attorney that clearly states that the agent is authorized for purposes of HIPAA to

view the medical records. If an emergency occurs it is essential that your agent has access to the proper information to make the right decision for your well being. The designated uses for Segment No. 1006 are navigation and industrial water supply. Numerical and narrative criteria to protect existing uses will be maintained. A Tier 2 review is not required since no exceptional, high, or intermediate aquatic life use water bodies have been identified in the discharge route. Existing uses will be maintained and protected. Truck plunges into San Jacinto River,

The bottom of the arrow shows where the truck landed on top of a chemical building at Huntsman Chemical, 150 below the bridge. The driver of the rig died pinned in his cab, as rescue workers tried to extract him.

bound lanes of the bridge after being sideswiped by another 18-wheeler that did not stop. A deputy had come upon the scene, and was just getting the information when the second 18-wheeler struck the stopped car and plummeted over the rail into the riv-

The truck's cab and trailer were submerged under water, and authorities called on divers to search the waters for the missing truck driver. The HCSO Marine Unit. HazMat team, firefighters from Highlands and Crosby, and the Coast Guard helped in the search. Due to the muddy water and the restrictions caused by proximity to the Waste Pits Superfund site, the driver was not found until Friday, in the cab of the

semi. He was identified by family as Steve Martinez, 60, of San Antonio.

Sheriff Gonzalez said the cab was buried in mud up to the windshield, and divers could not maneuver in the remaining space, and also had to keep wearing protective gear because of the nearby toxic waste pit material.

After finding the driver, authorities turned to the task of removing the truck from the river. They decided it could not be done from land, and secured a salvage barge from Galveston with a heavy-lift crane for the work.

By Saturday afternoon the salvage work was completed, the truck was lifted from the river in three parts, and the scene had returned to a quiet state.

The location of this accident was just on the other side of the river channel from an accident that occured in May, when an 18wheeler struck the side of a car in the westbound lanes of the bridge as it was changing lanes. The collision sent the auto over the railing and through a gap between the eastbound and westbound lanes. The car landed on its roof on the riverbank, and a 4 year old child, Andrea Salas, was killed. She was not in a seat belt, authorities believe. Her parents did survive the fall with only minor injuries. The

Authorities cautioned that these accidents occured from excessive speed, unsafe distance between vehicles, unsafe lane changes, and distractions while driving.
