Harris County Attorney discusses community protection with Northeast Harris County Bar Association

Harris County Attorney Vince Ryan met with the Northeast Harris County Bar Association at Los Cucos restaurant in Kingwood on Friday, Sept. 13 to describe the Office's community protection program.

county Attorney Ryan, along with Celena Vinson, Managing Attorney for Litigation, discussed how the County Attorney's Office uses civil law to rid neighborhoods of enterprises that foster crime.

"We have a duty to protect our community from those who want to operate illegal businesses," said County Attorney Ryan. "As the third-largest county in the nation, we are facing new challenges that others have not yet seen."

The Harris County Attorney can take legal action against owners who create situations that encourage crime on or around their property. The County Attorney works with owners of properties to develop ways for the owners to take steps to discourage criminal activities.

Vinson said the most common nuisances the office sees are illegal game rooms, massage parlors, smoke shops, and motels that permit prostitution on their premises. "We work with law en-

"We work with law enforcement agencies to constantly check on these places to make sure they're adhering to court orders," said Vinson. "We sometimes have to go after the landlords who knowingly allow their tenants to operate outside the law."

Although the lawsuits are filed in civil court they deter criminal behavior. The County Attorney has obtained court orders to require property owners to employ security guards, repair fences,

add surveillance cameras, fix broken lighting, and screen tenants for felony backgrounds.

The program has had success across the county with closures of a number of illicit spas, game rooms, and after-hours bars. The County Attorney's Office has been successful in filing suit against apartment complexes where prostitution, narcotic offenses, and aggravated crimes have taken place.

Since January of this year, the community protection group has sent leters or filed lawsuits resulting in the closure of 19 illicit massage parlors.

"We are all partners working together to keep our community safe," said County Attorney Ryan. "Our program has proven to be effective, and we will continue to work together to keep illegal enterprises out of our neighborhoods."

NOTICE OF TAXPAYERS' RIGHT TO ROLLBACK ELECTION

If taxes on the average residence homestead increase by more than eight percent, the qualified voters of the district by petition may require that an election be held to determine whether to reduce the operation and maintenance tax rate to the rollback tax rate under Section 49.236(d), Water Code. Notice of Tax Revenue Increase

The Harris County Emergency Services District No. 80 conducted public hearings on September 12, 2019 and September 16, 2019 on a proposal to increase the total tax revenues of the Harris County Emergency Services District No. 80 from properties on the tax roll in the preceding year by 4.87 percent.

The total tax revenue proposed to be raised last year at last year's tax rate of \$.04833 for each \$100 of taxable value was \$919,745.

Explanatory Statements for the November 5, 2019 Constitutional Amendment Election

Proposition Number 1 (HJR 72)

HJR 72 proposes a constitutional amendment permitting or collecting an individual inan elected municipal judge to serve as a municipal judge in more than one municipality at the same time. Unlike an appointed municipal judge, an elected municipal judge may not concurrently hold another municipal judge office. This amendment would allow an elected municipal judge to serve as a municipal judge in more than one municipality at manner as appointed municipal judges.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment permitting a person to hold more than one office as a municipal judge at the same time.

Proposition Number 2 (SJR 79)

SJR 79 proposes a constitutional amendment authorizing the Texas Water Development Board to issue additional general obligation bonds, in an amount that does not exceed \$200 million, for the economfor the development of water supply and sewer service projects in those economically distressed areas as defined by

The proposed amendment follows: "The constitutional and improving state and lothe issuance of additional by the Texas Water Development Board in an amount not to exceed \$200 million to provide financial assistance for the development of certain projects in economically distressed areas."

Proposition Number 3 (HJR 34)

HJR 34 proposes a constitutional amendment allowing the legislature to temporarily exempt from ad valorem taxation a portion of certain property located in an area covered by a disaster declaration of the governor. The proposed amendment would allow the legislature to prescribe the method of determining the amount of the tax exemption and the duration of the exemption and also would allow the legislature to create any additional eligibility requirements for the tax exemption.

Proposition Number 4 (HJR 38)

HJR 38 proposes a constitutional amendment prohibiting the state from imposing or collecting an individual income tax, including an individual's share of partnership and unincorporated association income. There is no current available school fund." constitutional bar on imposing

Proposition Number 5 (SJR 24)

SJR 24 proposes a constitutional amendment that would automatically appropriate the net revenue received from the portion of the state's tax revenue received on sales of sporting goods to the Texas Parks and Wildlife Department (TPWD) and the Texas Historical Commission (THC). The legislature would maintain the authority to determine the specific uses of the funds and their allocation between TPWD and THC.

Proposition Number 6 (HJR 12)

\$3 billion to \$6 billion to be issued by the Texas Public Finance Authority. CPRIT was created in 2007 to promote and fund cancer research in Texas. CPRIT uses bond proceeds to award grants for cancer research and prevention.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment authorizing the legislature to increase by \$3 billion the maximum bond amount authorized for the Cancer Prevention and Research Institute of Texas."

Proposition Number 8 (HJR 4)

HJR 4 proposes a constitutional amendment creating the flood infrastructure fund as a special fund in the state treasury, using money appropriated from the economic stabilization fund. The flood infrastructure fund would provide additional resources to implement plans to mitigate flood damage. The proposed amendment would authorize the Texas Water Develop ment Board to use money in the flood infrastructure fund for drainage, flood mitigation, or flood control projects. The proposed amendment also would authorize the creation of separate accounts in the flood infrastructure fund as neces sary to administer the fund or authorized projects.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment providing for the creation of the flood infrastructure fund to assist in the financing of drainage, flood mitigation, and flood control projects.'

Proposition Number 9 (HJR 95)

HJR 95 proposes a constitutional amendment authorize ing the legislature to create a property tax exemption for precious metal held in a precious metal depository located in this state.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment authorizing the legislature to exemp from ad valorem taxation precious metal held in a precious metal depository located in this state.

Proposition Number 10 (SJR 32)

SJR 32 proposes a constitutional amendment authorizing the legislature to allow a state agency or political subdivision to transfer a law enforcement animal to the animal's handler or another qualified caretaker in certain circumstances. Currently, the Texas Constitution prevents the transfer of certain public property, such as law vate person or organization a no cost. This amendment authorizes the legislature to allow the transfer of a law enforcement animal to the animal's handler or another qualified caretaker at no cost, upon the animal's retirement or at an other time if the transfer is determined to be in the animal's best interest.

Crosby ISD announces semifinalist in 2020 National Merit Scholarship program

CROSBY, Texas -Crosby Independent School District an nounced Crosby High School Senior, Bailee CoVan, as a National Merit Scholarship Program Semifinalist. Semifinalists have the opportunity to continue in the competition for some 7,600 National Merit Scholarships worth more than \$31 million that will be offered next spring.

Semifinalists must fulfill several requirements to advance to the Finalist level of the competition. Over 1.5 million juniors in about 21,000 high schools entered the 2020 National Merit Scholarship Program by taking the 2018 Preliminary SAT/National Merit Scholarship Qualifying Test, which served as an initial screen of program entrants. The nationwide pool of Semifinalists, representing less than one percent of U.S. high school seniors, includes the highest-scoring entrants in each state. Over 90 percent of the Semifinalists are expected to attain Finalist standing, and about half of the Finalists will win a National Merit Scholarship, earning the

Merit Scholar® title. Finalists will be notified in February of 2020.

She has played for Crosby High School's Varsity Soccer Team since her freshman year, President of the Crosby 4-H Club, and Vice President of the Senior Class of Crosby High School. Taxpayer questions \$70 million Newport bond proposal

to get a Bond Issue passed in today's climate:

a) Don't let you're voters know about the issue until the last minute while that appear to favor the issue. The whole time you're delaying information you're getting all your forces together so that when you do break the news you control it by overshadowing

any opposition.
b) Be up front, transpar ent with full disclosure. Have lots of community meetings and provide information and give time for this information to be

checked out.
I think it's obvious which approach this Board has taken. The problem is that the Board has hired a PR firm for the purpose of getting this information out and this Bond passed.

I'm just not happy with the way the Board went about going for this Bond Issue and why at this time. The Board should have alerted the tax payers and had open meeting at their Board meetings discussing and not restrict this important issue to 5 minute comets before the Board discusses it. Let's be clear, we are not in a crisis situation, that if this Bond doesn't pass, that Newport Mud system will crater. The Board has spent a

lot of time on developing a 10 year plan which I'm in favor of doing and they did an excellent job. But to put a Bond Issue together of \$70,000,000 is just too much for a subdivision that is 90-95% built out. This 10 yr. plan will span 3 Board Elections. There is a lot of land outside the MUD District waiting to be annexed. The outside influences of promoting favorable Board members for future Board positions for this purpose causes concern for me. I'm afraid that Builders will come in and want annexation with reimbursement agreements and subdivide these new tracts into 45 foot lots thereby clearcutting all the

The Board has not shown strength enough to prove to the tax payers that for any new annexation to occur that the lot size must be large enough to support no clearcutting of trees as the original developer provided. Make no mistake about it, before any annex ation could be approved the Board can require the Developer to do certain things. The idea that because we have been giving Builder reimbursements in he past without these requirements is no longer valid in my opinion because we are using new bond money. I would happily welcome builders that would develop lots large enough to keep mature trees as Newport should always welcome new growth that is harmonious with our lovely

The Board would like to pass this Huge \$70,000,000 so they don't have to come back to you in the future like all Boards do. The last Newport Bond Issue was for \$30,000,000 and \$5,000,000 for Parks This was for a half built out subdivision and the Board set aside approx. \$12,000,000 for Builder reimbursement with the promise that the reimburse ments to the builders would be offset by the value that the Builder put on the ground, therefore these reimbursements would not he a reason for a tax increase and the previous Boards have keep their word. This \$12,000,000 was to help spur the growth of Newport; it lasted about 20 years and during that time

expansion and Water Plant expansion. With the growth of Newport it will be necessary for both the water and sewer plant to be expanded. The Engineer said the cost of both should be about \$18,000,000. This needs to happen by 2025 and it takes about 2 years

from planning to finish.

That's right the builders have already peeled a reimbursement from this Bond Issue. So when the MUD does a project and submits for Bond money we must include this also. We got development but it also got 45 foot lots and clearcut-ting of trees. It's now time to pay up – but we don't have to with this Bond issue as the Builder has agreed he will wait as long as it takes So let's do this right and do our homework as tax payers, the Board did theirs as Board Members. Let's just give the Board the authority to meet TCEQ requirements and finish the Water and Sewer plant expansion. Report provides details on what can be done to prevent shootings

AUSTIN — Gov. Greg Abbott on Sept. 12 released the Texas Safety Action Report, a document that details what Texas and Texans are doing to prevent mass shootings.

The report elaborates on executive orders Abbott issued a week earlier to coordinate state and local expertise and resources and "identify any shortcomings in our current systems and explore ways to prevent these horrific tragedies from taking place.

Abbott said strategies laid out in the report result from meetings with law enforcement officials; community, business and faith leaders; technology experts; counselors; advocates; lawmakers and survivors of mass shoot-

"We must act with resolve in response to the despicable acts of violence we have witnessed in Texas," said Abbott. "Solving the problems that have led to these horrific events will take more than governmental action. The complete solution will require more than what is outlined in this paper. It will require parents, families, churches, law enforcement community groups, schools and others working together to fortify the social fabric of our society. Texans are at our best when we are tested. Together, we will transcend this test and forge an even better future for our state.'

Here are some of the actions recommended in the report:

-Refresh training for all licensed peace officers on the procedures and criteria for "emergency detention" of individuals who pose a danger to others or themselves;

-Educate physicians and behavioral health professionals about the law concerning disclosure of confidential information to law enforcement:

—Accelerate the development and implementation of the Texas Department of Public Safety safe firearm storage campaign, supported by a recent \$1 million appropriation:

-Expedite the reporting of criminal convictions to the Texas Department of Public Safety:





-Prohibit straw purchases of firearms under state law: —Enact laws that crack

down on criminals who try to illegally buy or possess

—Require courts to inform convicted criminals, both orally and in writing, that they may no longer sess firearms; and

—Encourage social media companies to report suspicious activity to law enforcement.

could be deadly, they were warned.

The protesters said that their plan was to dangle in place for 24 hours, but as of Thursday evening, only 12 hours into the incident, authorities had removed most of them.

Northbound traffic across the bridge was severly interrupted during the police activity. Harris County Sheriff's deputies had arrested the 12 on the bridge earlier, and were working with the Houston and Baytown fire departments to lower the rest of the protesters to boats below, from the Coast Guard, Sheriff's office and Houston police. Demonstrators were taken into custody

after lowered to the boats.
On Friday, the 23 protestors bonded out of jail, but face charges of obstruction of road and ship channel that could lead to a year in jail and a \$10,000 fine.

Seminar Addresses Common Liver Disease

BAYTOWN — (September 13, 2019) — For a disease that is classified as "common," nonalcoholic fatty liver disease (NAFLD) flies under the radar for most people.

The term nonalcohol-

ic fatty liver disease is used to describe a range of liver conditions affecting people who drink little to no alcohol. It impacts nearly 100 million people in the U.S. The main characteristic of NAFLD is that too much fat is stored in liver cells, but it frequently has few warning signs or symptoms in its earliest stages. Left untreated, NAFLD may lead to very serious consequences.

Dr. Rashid Khan, a gastroenterologist/hepa-tologist with Houston Methodist Gastroenterology Associates in Baytown, says the cause of the condition is difficult to determine, but knowing your risk is essential. He provides information on the possible causes, symptoms and treatment options for NAFLD when he hosts a free informational seminar on Thursday, September 19 from 6 to 7:30 p.m. in the conference center classroom at Houston Methodist Baytown Hospital. The event is held in association with the American $Liver\ Foundation\ (ALF).$

"The condition may be diagnosed in people of all ages, but it is especially prevalent in people in their 40s and 50s who are at high risk of heart disease due to the presence of risk factors like obesity and type 2 diabetes," Khan said. The condition is also closely linked to a cluster of abnormalities

called metabolic syndrome that include increased abdominal fat, poor ability to use the hormone insulin, high blood pressure and high blood levels of triglycer-

Khan says NAFLD's link to liver cirrhosis is the biggest reason why the condition should be taken seriously.

"Fatty liver is generally benign, but the development of cirrhosis is a possible consequence,' Khan said.

Along with the potential risk of cirrhosis, Khan says NAFLD brings an increased risk of developing liver cancer. Studies have shown that this risk is even present in the absence of cirrhosis. There is also a link between chronic kidney disease (CKD) and NAFLD and the condition may also in-crease the risk for cardiovascular disease. Research indicates that many diabetic patients eventually develop

NAFLD. While the onset of nonalcoholic fatty liver disease frequently does not include symptoms, when symptoms are present they may include enlarged liver, fatigue and pain in the

upper right abdomen. Khan says choosing a healthy diet rich in fruits, vegetables, whole grains and healthy fats, maintaining a healthy weight and getting reg-ular exercise may be effective in lowering the risk of NAFLD. The first line of treatment generally involves weight loss through eating a healthy diet and exercising regularly, although weight-loss surgery may be an option for those who are morbidly obese.

Because symptoms may not be present, Khan says regular screenings, including blood and liver enzyme and function tests, may be effective in detecting the disease in its earliest stages.

Medicare Open Enrollment

It's that time again. Every year we have the opportunity to make changes to our Medicare plans between Oct. 15 and Dec. 7. We have the option of changing from original Medicare to an Advantage plan, or vice versa, or changing to a different Advantage plan. We also can change our Medicare Part D drug plan. The decisions aren't easy. After all, we have to live with them for the next year.

We'll soon receive a new Medicare & You book in the mail, as well as notices about any changes to our current coverage. While we can usually stay with the plan we have if we don't want to make any changes, it's important to review everything we're sent, because there might be new information buried in the language. Sometimes a plan is discontinued! The premium can change. Coverage details might be different. Read the fine print and be certain that your coverage will be what you expect.

For Advantage plan changes, there is

For Advantage plan changes, there is an additional open enrollment period: Jan. 1 to March 31. This was new for 2019 and gives three extra months to decide on an Advantage plan. Beware: You can change your mind about Advantage plans a few times during fall enrollment, but only once during the first three months of the year.

If you're signing up for Medicare Parts A and B for the first time, you have a seven-month period to do it: the three months before you turn 65, the month you turn 65 and the three months after you turn 65. If you don't sign up for Part B in time, you can be forced to pay a penalty for the whole time you have Part B. Keep an eye on the dates!

ODonnell et al. v. Harris County et al. is a class action lawsuit that was filed in federal court in 2016 Dominen et al. v. natris courny et al. is a class action lawsuit that was filed in federal court in 2016 claiming that the bail practices for misdemeanor arrestees in Harris County were unconstitutional. The parties have reached a settlement that they believe is fair to both sides. If you are a Class A or Class B misdemeanor arrestee currently subject to Harris County's bail practices, then you are a member of the class. This notice explains the proposed consent decree and settlement, which are available at https://www.harriscountycao.org/bailsettlement and how you can tell the Court if you think the agreement is unfair.

First, the consent decree gets rid of the prior secured bail schedule and requires that Harris County and the other Defendants follow a new local rule that ends the practice of jailing people because they are too poor to pay predetermined amounts of money. The rule makes sure that people charged with most offenses will be released promptly after arrest on a personal bond without having to see a judge. For those people falling into several categories of offenses, the rule ensures that they will have a prompt individualized bail hearing that meets strict constitutional standards. The rule ensures that not always member can be detained prior to trial unless the government makes a determination that such detention is necessary because no alternative conditions are sufficient to serve its interests in public safety or prevent flight from prosecution. The rule ensures that such a determination can only be made after an adversarial hearing, notice, representation by counsel, the ability to present and confront evidence, and findings on the record by clear and conviction evidence. findings on the record by clear and convincing evidence. To read the rest of the provisions of the rule please see Exhibit 1 to this Notice

Second, the consent decree includes a number of provisions designed to ensure that Harris County invests in support services, logistics, technology, and systems to ensure that the new bail practices function properly and are enduring, and that the system does not revert to unconstitutional customs and practices. These provisions include infrastructure investments to technology systems, investments in awyers for indigent arrestees, investigative and social work services to assist indigent defense counsel, mproved systems on court notification, new policies regarding nonappearance in court, and studying

and investing in practices that mitigate nonappearance.

Third, the consent decree requires the County to collect and analyze a wide range of data that will enable the public and the court to evaluate the improvements and whether they are protecting

will enable the public and the court to evaluate the improvements and whether they are protecting the rights of class members.

Fourth, the consent decree puts in place a Court Monitor, who will scrutinize the County's compliance with the terms of the consent decree and report back to the federal court, class counsel, and the public.

In addition to the consent decree, the parties have agreed to a settlement to resolve the Plaintiffs' remaining claims. As part of the settlement agreement, the County agrees not to oppose Plaintiffs' attorneys' fees requests in the amounts provided in the agreement, available at https://www.hariscountyea.org/balisettlement. The amounts arrived at are \$150.424.50 in costs and expenses and \$4,540,399.90 in fees, which represents thousands of hours of work over more than four years of investigation and flitigation of this important case. Some of the Plaintiffs' lawyers have agreed to donate their fees, in an amount of \$2,161,282, to the County to support implementation of the Consent Decree and provide other services to indigent misdemeanor arrestees.
