

## Pct. 2 expanding 'Homebound Senior Food' delivery program

New online portal and phone hotline will enroll qualifying seniors for daily hot meal delivery

HARRIS COUNTY PCT. 2 - With the thought that no one should go hungry during the current Harris County Stay-At-Home order, and because many in elderly population already have difficulties getting out anyway, Commissioner Adrian Garcia is expanding the existing

free hot meal delivery program in Precinct 2. Any Precinct 2 resident who is age 60 or older possessing limited resources and is unable to leave home due to illness, disability, or lack of mobility qualifies.

Seniors that qualify will receive daily, nutritious hot meals delivered directly to their door by Precinct 2 staff. Anyone who believes they are eligible for this service is asked to register on an online form on the Harris Co. Precinct 2 website (www.hcp2.com/ programs/precinct-2-mealprogram). Those without to apply over the phone via the Precinct 2 Hotline (713-274-2222) which is active Monday - Friday from 8 a.m. to 4:30 p.m.

Commissioner Adrian Garcia issued the following

"During this crisis, we will not forget our most vulnerable residents of Precinct 2, such as homebound seniors. I have instructed my staff to expand our current homebound senior food delivery program by signing up any



and all seniors who are struggling and are unable to leave their Precinct 2homes, due to illness, dis-

ability, or lack of mobility. Our current program is great, but I know there is going to be an increasing need for help, and we are preparing to meet the de-

#### Eligibility

After submitting an application, a Harris County Precinct 2 representative will evaluate applicants' conditions. Evaluations will include assessing the ability to perform daily activities such as food preparations and shopping, how often the applicant leaves their home, as well

as their access to other assistance services. Note: All information gathered is totally confidential, and records are kept at the Harris County Precinct 2 service provider's office.

People may qualify for home deliveries if they are: Ages 60 and over.

- Homebound due to illness, disability, or frailty.

- Unable to prepare nourishing meals due to limited mobility, psychological, or mental impairment.

Without resources such as family and friends.

#### FM 1490 Groundbreaking

Mont Belvieu - The FM 1409 extension has officially started construction last Monday, April 6.

The new road will extend FM 1409 from FM 565 in Old River to FM 565 in Cove. The extension will provide a two-lane undivided highway which will eventually cross over IH-10. Phase 1 of the project consists of both FM 1409 from N. FM 565 to IH-10 westbound frontage road, and FM 1409 from IH-10 eastbound frontage road S. FM 565; which is slated to be completed by November

Phase 2 consists of the FM 1409 bridge; which will be out for bid

Commissioner Pct. 3 Gary Nelson said it will provide traffic relief to Eagle Drive. Judge Sylva praised the teamwork to accompllish the project.

#### **Judge Sylvia** signs **Amendment 3** of Executive Order

#### Chambers County FREQUENTLY ASKED **OUESTIONS**-Stay Safe Order

Can I go to work? Yes, but only if you are deemed an employ ee of an Essential Business, such as grocery store employees, healthcare providers, construction, industry and more. Those whose jobs are deemed essential are expected to maintain social distancing standards in the workplace.

Employers are encouraged to remember that congregations of people on any premises - either public or private - are prohib-

According to the federal government's Cybersecurity and Infrastructure Security Agency guidelines, there are 16 sectors considered essential:

- Communications
- Chemical
- · Critical Manufacturing · Commercial Facilities
- Defense Industrial Base
- Emergency Services Energy
- · Food & Agriculture Government Facilities
- Healthcare & Public Health
- Information Technology
   Nuclear Reactors, Materials and Waste
- Transportation Systems
   Water/Wastewater Systems

Can I still go to the store to buy groceries? Yes, grocery tores will remain open during the order. However, all grocers will be required to keep customers at least six feet apart to meet social distancing standards. Health officials do not recon leaving the house unless it is an absolute necessity. ONLY ONE HOUSEHOLD MEMBER should visit the grocery store at a time.

<u>Can I go to church?</u> No, all Chambers County churches will

be required to host religious services online only. There can be exceptions made for one-on-one meetings for spiritual and mental health, but individuals involved must maintain social distanc-ing requirements.

Can I still visit public parks? Yes, all public parks will remain open. However, visitors must stay six feet apart from one another. All public benches, exercise equipment, playgrounds and

Is fishing permitted? Fishing is permitted. Boat ramps are open for public use

Can I camp (either in a camper, RV or tent) at Chambers

What if I need to leave my house to care for someone else, such as an elderly relative? You are allowed to leave your home for emergency/essential care of family members, pets, and other loved ones.

Are restaurants closing? No, Chambers County restaurants are still allowed to serve to-go and drive-thru orders, but customers picking up food will be required to stay six feet apart.

Are pet supply and/or care facilities permitted to stay Yes, pet supply, pet care and pet grooming facili permitted to stay open

Are childcare providers allowed to provide services to all citizens or only to those with jobs that are deemed essential? Childcare providers are allowed to provide services to all citi-

Is travel restricted in Chambers County? The Stay Safe Or-Can COVID-19 be transmitted through mosquitos or ticks?

Are homebuilders considered essential industry? Yes, homebuilders are considered essential and may continue with

 $\underline{\textbf{Can I still go to convenience stores?}} \ \textbf{Yes, however no food}$ service establishment, convenience store or other retail establishment is permitted to allow customers to self-serve ready to eat food or drinks. This includes buffets, beverage dispensers and customer self-service stations.

I operate or manage an Essential Business. Should I be screening my employees before they enter the premises? Yes, the CDC recommends that businesses screen employees before allowing them to enter the premises. Visit cdc.gov for more infor-

Individuals who violate these restrictions could face a fine of \$1,000 or up to 180 days in jail.

## Bob Boyles leaves a legacy of dedication,

CROSBY - Few leaders of a community have held so many leadership positions as did Bob Boyles and few have left a legacy that is dedicated to saving lives and guarding the security of a community.

On March 19, 1981, a vehicle was pulling out from a side street as a Crosby Fire Truck approached, a collision was to be immenent so Bob Boyles Jr. swirved to avoid injuring someone else, in the disaster that followed, the son of a community leader lost his life.

In that year a young Alan Kulak was mascot for the department, they told him he was too young to be a fireman at age 15, and he was training under Bob Junior to take on skills needed to save lives and fight fires. Now Fire Chief Kulak believes that due to the loss of his son in the line of duty, Bob Boyles dedicated himself to making Crosby have a great a fire department as it could

possibly afford. He was elected President of the Board of Directors in 1982 when Crosby Firefighters had to relay only upon donations from the general public and fundraising to keep fight-

Boyles spearheaded many of the fundraising

drives himself in those days, his dedication extended to asking for donations.

In 1988 a young Assisgoing to Boyles to ask if it was possible to obtain a tanker for the department as this equipment would greatly expand the capacity of the firefighters to battle large flames. Boyles went to work finding a finance company that would extend credit to an organization that was running completely off of donations Boyles came though and the department ordered its first tanker in 1989.

Boyles again got financing for badly needed equip-ment when the ladder truck was so delapidated it was costing more to keep it running than a new truck would cost in 1991. The department had not hardly begun paying off the tanker when Boyles got financed a new ladder

"Bob always went above and beyond to keep our equipment operational thoughout the late 1980's and 1990's before we had a tax basis." reports Chief Alan Kulak.

Boyles lead the charge to get a tax basis in 1998 and lead the effort to bring the ISO insurance improvements of 1999. That

I will miss our conversations over our favorite adult beverages, to himasking 'How is everyone at your house."

In 2016, Bob's efforts in administration of the Fire Department, veterans affairs and adminstration of the Crosby American Le-gion Post 658 were recognized as he was presented Citizen of the Year by Eastside Veteran's Celebration at the Crosby Fair & Ro-

"essential business" should be away from home. A list of these is on page 3.

Testing for anyone with the symptoms of the virus, which include a fever over 100.4 degrees, a dry cough, difficult breathing, chills, runny/stuffy nose, shortness of breath, sore throat, recent international travel, or exposure to someone suspected of having the virus or reasons for getting a test. This will allow you to get treatment, and give the health authorities information about the spread of the disease.

Congresswoman Sheila Jackson Lee opened a third private drive-thru test site at Forest Brook Middle working with UMMC, the

United Memorial Medical Center. Testing at this site is free, and does not require prescreening. This is the third site she has opened in the area, including a site at 510 West Tidwell and another at the Smart Financial Centre in Sugarland.

Jackson said "We have done this to save lives.' She said the choice of Forest Brook Middle School as a site was because census data indicated a high number of senior citizens who live in the area.

The Congresswoman said the sites she has worked to open are meant to compliment the city and county-backed testing sites that have also opened

About 3,000 people have een tested since the first UMMC testing site opened, officials said. Each site can test about 250 to  $350~{\rm persons}$  per day. They are open from Monday to Friday, 8am to 8pm. About 9% of the tests have come back positive, officials said.

People with symptoms are allowed to go to the testing sites, where they will be screened before being tested. Results are available in a few days.

Sheila Jackson Lee has also participated in the few "pop-up" test sites. On Monday of this week, she was at the community center in Jacinto City, where she helped test first re-

## **EPA Awards State of Texas** More Than \$1.5 Million to MonitorParticle Air Pollution

DALLAS (April 2020) — Recently, the U.S. Environmental Protection Agency (EPA) awarded the state of Texas \$1,543,710 to monitor air quality for fine particulate matter. also called particle pollu-tion or soot. The grant is provided under a coopera-tive agreement with the Texas Commission on En-Quality (TCEQ) to develop and maintain monitoring programs under requirements of the federal Clean Air

"Monitoring for particle pollution is crucial to controlling it and protecting public health in our communities," said Regional Administrator Ken Mc-Queen. "EPA is proud to supporting TCEQ's strong air quality programs with this grant."

The grant covers programs to monitor fine particulate matter, which consists of solid and liquid particles no larger than 2.5 microns in diameter. The funding will help TCEQ's air monitoring program prevent and control air pollution and implement national primary and secondary air quality stan-

Particulate matter, also called particle pollution contains microscopic solids or liquids which may be harmful if inhaled. The particles can become lodged in the lungs, or can even get in your blood-stream, causing respiratory or heart problems. People with heart or lung

disease, children, and older adults are most likely to be affected by particle pollution. The particles also affect the environment, with the smallest being the main cause of reduced vis-

ibility (haze).

Online Instruction Creates Balancing Act

By striving for a balance, Angie Johnson finds she is able to manage her roles as wife and mother as well as online teacher to her students and director of "Johnson Academy" as her two children work from home on their own assign-

Johnson teaches Computer Science, Teen Lead-ership and Career Preparation at Goose Creek Memorial High School where she is the 2019-20 Teacher of the Year. She also was selected as the District Secondary Teacher of the Year and a finalist for Region 4 Teacher of the Year. Begles UIL Academics and Student Council, so her organizational skills have been an asset to her even more since the district closure to prevent the spread of COVID-19 has upset everyone's routine.

"It's definitely been a change and definitely some adjustment, but we're go-ing with it, and we're trying to stay positive about it and doing the best we

can," Johnson said.
"I set up my little office station in one corner, and I have my daughters on each side of me. Number one, it's always good to have the parent in the middle because, as you know, siblings sometimes battle it out with opinions," said

She first thought that they would all just work at the same time, but she soon found out that each daughter needed her at a specific time, so she had to work out a schedule. After waking up, having breakfast and getting ready for the day, they start off with dents all over the Houston area, facilitated by Velia Gates at Bowie Elementary. The students draw and do other activities, such as hang artwork honoring first responders on their window to demonstrate their appreciation of them. Johnson plans to take her turn at leading the classes soon to teach some coding

apps.

Following more assignments, they have lunch and recess, going outside to walk or ride bikes to break up the monotony of staring at a computer screen all day. Then, it's back to work for the afternoon, and Johnson can check students' assignments and log on for her office hour.

Although it sounds like she has perfected a system, Johnson admits here are both of her children needing her attention at the same time.

She schedules breakfast and lunch, putting healthy snacks in a small bin so that they can get to them easily, but she stills finds time management a chal-


"It has been a struggle to be a mom to kids in more than one grade level and also to give my students and my teachers I help out some of my time. I'm just trying to find balance with meals and the curriculum and all of it," Johnson said

She does find, however, that this new schedule has some rewards, such as enjoying togetherness, reconnecting with her family and having some down time - although there's not much of that!

Johnson also makes sure to connect with her students through webinars. She talked to one stu dent, who struggles with depression, and she was also able to talk with her mother. She likes being able to conduct weekly check-ins with her stu-

dents just so she can make sure everyone is okay.

Another benefit is that

online instruction has pushed teachers to take advantage of technology and become more comfortable with it.

Special Education ARDs are conducted through virtual meetings, and Johnson sets up weekly department meetings for Career and Technical Education (CTE) teachers. "I

think moving forward, I wouldn't be surprised if all teachers started making sure that they have things set up so if we ever get into a situation like this it is a smoother transition," she

She praises the Technology Department members for their hard work.

While there are some positives, as the school year progresses, Johnson, like most teachers, misses

seeing her students, and even the best balancing act cannot change that.

"Not getting to see them, not getting to greet them at the door, not getting to give them a high five or just be there with them! As an educator, you just feel sad and lonely You just want to see your kids," she said.

She sets up every class with the opportunity for

students to log in even if they won't show their fac-es on the screen, because she senses that they want the normalcy of connecting with their class, especially the seniors.

For now, Goose Creek CISD students and teachers will have to stay apart. but fortunately, they've found other ways to stay together.
