Harris County Fire Marshal encourages fireworks safety

Harris County, Texas --Fireworks are synonymous with the Fourth of July. They are beautiful, but can also be very dangerous if not used properly. The Harris County Fire Marshal's Office not only encourages residents to attend professional fireworks displays and practice fireworks safety but to also practice social distancing and wear masks.

"Professional fireworks displays are a great way for residents to safely enjoy fireworks, but with the spread of COVID-19 we are also encouraging everyone to practice social distancing and to wear masks," said Harris County Fire Marshal Laurie L. Christensen. "If you choose to use consumer fireworks, please read the cautionary labels and dispose of your fireworks properly."

The Harris County Fire Marshal's Office encourages residents to follow these recommended safety tips:
Follow the law. Make

sure fireworks are legal in your community.

Read and follow the directions and warning labels on fireworks packaging.

Never allow children to play with or ignite fireworks

Light only one firework at a time.

Do not point fireworks at homes, buildings, or people.

Never consume alcohol or drugs while shooting fireworks.

Make sure there is a bucket of water or water source nearby for emergencies and to soak used fireworks prior to disposing of them in the trash.

Be considerate of neighbors when it comes to noise and the trash left behind.

Pets and fireworks don't mix. The loud noises can cause pets to become anxious or afraid.

Consider celebrating the Fourth of July with fireworks alternatives. For example, glow sticks are a great alternative to sparklers. Sparklers may seem safe, but sparklers burn more than six times hotter than boiling water.

"Using consumer fireworks safely, attending a professional display, or finding alternative ways to celebrate, will reduce the number of incidents that require a response from first responders," said Fire Marshal Christensen. "Stay safe this Fourth of July holiday and help keep our first responders safe as well."

EXECUTIVE ACTIONS TO STOP COVID-19 SPREAD

Containing spread of COVID-19

Limits certain businesses and services with link to infections

2020 – Governor Greg Abbott issued an executive order limiting certain businesses and services as part of the state's effort to contain the spread of COV-ID-19. This decision comes as the number of people testing positive for COV-ID-19 and the number of hospitalizations have increased and the positivity rate in Texas increased above 10%, which the Governor previously stated would lead to further preventative action. The targeted, measured directives in the executive order are based on links between certain types of business-es and services and the recent rise in positive cases throughout the state.

The order includes the following:

All bars and similar establishments that receive

more than 51% of their gross receipts from the sale of alcoholic beverages are required to close at 12:00 PM today. These businesses may remain open for delivery and takeout, including for alcoholic beverages, as authorized by the Texas Alcoholic Beverage Commission.

Restaurants may remain open for dine-in service, but at a capacity not to exceed 50% of total listed indoor occupancy, beginning Monday, June 29,

businesses must close.
Outdoor gatherings of 100 or more people must be approved by local governments, with certain exceptions.

"As I said from the start, if the positivity rate rose above 10%, the State of Texas would take further action to mitigate the

spread of COVID-19," said Governor Abbott "At this time, it is clear that the rise in cases is largely driven by certain types of activities, including Texans congregating in bars. The actions in this executive order are essential to our mission to swiftly contain this virus and protect public health. We want this to be as limited in duration as possible. However, we can only slow the spread if everyone in Texas does their part. Every Texan has a responsibility to themselves and their loved ones to wear a mask, wash their hands, stay six feet apart from others in public, and stay home if they can. Additional reopening phases temporary paused

AUSTIN – Governor Greg Abbott today announced that the State of Texas will pause any further phases to open Texas as the state responds to the recent increase in positive COVID-19 cases and hospitalizations. Businesses that are permitted to open under the previous phases can continue to operate at the designated occupancy levels and under the minimum standard health protocols provided by the

exas Department of State

Health Services.

"As we experience an increase in both positive COVID-19 cases and hospitalizations, we are focused on strategies that slow the spread of this virus while also allowing Texans to continue earning a paycheck to support their families." said Governor Abbott. "The last thing we want to do as a state is go backwards and close down businesses. This tempo-

rary pause will help our state corral the spread until we can safely enter the next phase of opening our state for business. I ask all Texans to do their part to slow the spread of COVID-19 by wearing a mask, washing their hands regularly, and socially distancing from others. The more that we all follow these guidelines, the safer our state will be and the more we can open up Texas for business."

Letter to Chambers County Residents

I have received a lot of comments priticism and overwhelmingly positive responses regarding my decision to mplement Executive Order JS-7 andating that all Chambers County usinesses require the wearing of hasks by both employees and clients want you to know that our team heads every single comment, nessage and email and, though we are not able to respond to each one, I do consider your opinions and wellbeing when making decisions. I want to clarify that this decision

vas made based on facts and sound uidance from Public Health ther regional resources.

The number of confirmed positive es of COVID-19 has rise exponentially over the past few weeks. From March 16 – the date our first case was diagnosed – to May 31, Chambers County reported 68 cases In the past 25 days, we have nearly doubled that number with 123 new confirmed positive cases, for a total of 191 cases. In fact, there has been a 123 percent increase in the number of active cases over the last 10 days alone. We have also, sadly, reported our first two COVID-19 related deaths. An announcement that I hoped we would never have to make.

Regional hospital Intensive Care Units are nearing capacity. As of June 24, the Texas Medical Center reported that ICU's were 97 percent full and that, based on normal capacity counts, there were only 32 beds available.

I understand that not all ICU

patients are hospitalized because of COVID-19. Instead, the concern is that should a Chambers County resident become ill – either with COVID-19 related illness or any other illness - climbing COVID-19 numbers means that hospital bed space may not be available for those who need care, especially critical care bed availability.

We must also all remember that there are 7,169,252 people living in the Houston region, all vying for care at the same hospitals. Many other counties are experiencing the same surge in COVID-19 cases that we are which means that the available bed

Additionally, while Governor Greg Abbott did mandate that individuals cannot be fined for not wearing masks (something we would never want to do, regardless), he did state in an nterview with KWTX-Waco that "loca governments can require stores and businesses to require masks." He continued, "they have always had the opportunity and ability. Just like they can require people to wear shoes and shirts, these businesses can require

Judge Sylvia issues order requiring wearing of masks seeks residents

Judge Jimmy Sylvia issued Executive Order JS-7 mandating that all businesses require the wearing of face masks beginning Thursday, June 25, 2020.

'The number of confirmed positive cases of COVID-19 is rising rapidly and we just reported our first deaths," said Judge Sylvia. "We all have to take action to contain the spread of this disease.

According to Judge Sylvia's Order, all commercial entities providing goods or services directly to the public must require that all employees or visitors wear face coverings within areas where they will be in close contact or proximity to others.
"I understand that this

may be an unpopular decision," said the Judge. "We are doing everything we can to keep businesses open, though, and this is a step that we have to take to do that."

All Chambers County residents over the age of 10-years-old are required to wear a face covering over their mouth and nose when in a business or when working in close proximity to others, except:

- When exercising outside or engaging in physical activity outside;

- While driving alone or with passengers who are part of the same household as the driver;

- When doing so poses a greater mental or physical health, safety or security risk;
- While pumping gas or

operating outdoor equipment; - While in a building or activity that requires security surveillance or screening (i.e. banks); or

When consuming food or drink

Acceptable face coverings include homemade masks, scarfs, bandanas or handkerchief. It strongly recommended that people do not obtain or wear medical masks or N-95 respirators, as they are a needed resource for healthcare providers and first responders.

"Please remember: face coverings are not a replacement for social distancing, frequent hand washing and self-isolation when sick," continued Judge Sylvia.

Residents should maintain the following habits while in public:
- Washing hands before

you leave home and when - Staying at least six feet

Houston Methodist Baytown Hospital implements revised visitation policy

BAYTOWN - (June 26, 2020) - Due to the current rise in positive COVID-19 test results and hospitalizations throughout the Greater Houston Area, effective Friday, June 26, Houston Methodist Baytown Hospital implements a revised inpatient visitation policy that no longer permits visitors for admitted hospitalized patients.

The policy is implemented in order to ensure the safety of patients and caregivers. In effect at all Houston Methodist facilicompassionate exceptions to be made for visitors over the age of 18 in certain situations, including:

- Hospitalized materni ty, postpartum and NICU patients: One healthy partner/parent
- Disabled or impaired patients: One healthy visitor to escort and provide wheelchair assistance
- Critical patients (until stabilized): One healthy visitor • End-of-life patients:
- Two healthy visitors at a time, for one brief visit • Discharged patients: One healthy visitor for ed-

ucation at discharge

• Family conference, temporary need for family support (i.e.: following diagnosis): As requested by physician

SURGICAL, PROCEDURAL AND DIAGNOSTIC PROCEDURE PATIENTS

Patients are allowed one visitor 18 years or older who may stay until visit-ing hours end at 8 p.m. (on the day of surgery). This is a single visitor, not a rotation of visitors. This single visitor is not permitted to stay overnight or return the next day.

DOCTOR APPOINTMENTS

Patients are limited to one visitor 18 years or older. However, they are encouraged to come to the appointment alone. Visitors will be subject to the clinic's screening and pro-

tection criteria. There are no visitors allowed in the emergency room. Only an ER doctor may permit an exception to have tested positive or are under evaluation for COV $ext{ID-19}$ will not be permitted visitors.

Patients are encouraged to utilize electronic communication, such as smartphone or video chat in place of in-person visita tion whenever possible. Patients or family members should reach out to a patient relations representative or their caregiver to inquire about receiving an exception to the policy.

As the number of local COVID-19 cases increases, Baytown area residents are urged to wear masks while in public spaces, practice social distancing and wash their hands thoroughly and frequently to

help prevent virus spread. Houston Methodist Baytown Hospital is commit ted to providing its full range of medical services during the COVID-19 pandemic. Rest assured that the safety, health and wellbeing of all of our patients is our top priority. We have implemented the following

Ask Rusty – About Special Extra Earnings for Military Service

Dear Rusty: How do I find out if I get any extra earnings for my military service of 28 years (Navy, 1982-2011), when I begin collecting my full Social Security retirement benefit next year (in July 2021)? Signed: Retired

Dear Retired Veteran: First, as a fellow veteran, I want to thank you for your 28 years of military service, but I need to clarify what those "special extra earnings" are. That's not an additional amount which will be added to your monthly Social Security benefit as a bonus for serving. Rather it is an additional dollar amount which has already been added to your earnings record for the years you served in the military. Those receiving active

duty military pay have contributed to Social Security since 1957, and that record of your military pay is already on file with Social Security But a long time ago Congress decided to bump up the recorded earnings of those with earlier military service to make it easier for them to qualify for Social Security, and to possibly provide a slightly higher benefit when the earnings from those years in the military are included in the computation of SS benefits.

To compute your benefit, Social Security uses the 35 highest earning years from your lifetime earnings record (adjusted for inflation) So, if your earnings during the years you were in the military are among the 35 years used to calculate your SS benefit, those military earnings were supple mented with an additional amount to make them up to \$1200 per year higher than you were actually paid. And that higher earnings amount possibly means a higher Social Security benefit because it could make your lifetime Average Indexed Monthly Earnings (AIME) higher (a higher AIME translates to a higher benefit

In your case, an extra \$100 for every \$300 in your actual military pay should have been added

to your earnings record for each year you served between 1982 and 2001 (maximum of \$1200 for each year).

For service years after 2001, no additional "special credits" are awarded. To verify this, you may wish to obtain a copy of your lifetime Earnings Statement from Social Security and verify that your recorded earnings for 1982 - 2001 are \$1200 more than you were actually paid while serving. And if not, you should supply a copy of your DD-214 when applying for your Social Security benefits. You can obtain a copy of your lifetime Earnings Statement online if you have a personal "my Social Security" account at www.ssa.gov/myaccount; otherwise you'll need to request a copy directly from Social Security.

tion applicable to those who served prior to 1978, computation of their "special extra earnings" were computed a little differently. For those veterans, the maximum annual "special extra earnings" supplement was still \$1,200, but the method for computing their extra earnings was to give an extra \$300 for each calendar quarter of active duty military service. But in any case, the special extra earnings are an addition to your military pay record on file with Social Security, not an additional dollar amount added to your Social Security benefit.

Governor's order restricts alcohol-serving establishments

AUSTIN — Gov. Greg Abbott ordered the state to slow down the reopening process for bars and other venues as coronavirus-related infections, hospitalizations and deaths continued to increase in Texas last week.

"As I said from the start, if the positivity rate rose above 10%, the State of Texas would take further action to mitigate the spread of COVID-19," Abbott said. "At this time, it is clear that the rise in cases is largely driven by cer-tain types of activities, including Texans congregating in bars.

Abbott ordered bars and other state-licensed establishments that receive more than 51% of their gross receipts from the sale of alcoholic beverages to close at noon on June 26, but allowed them to continue offering delivery and take-out services until further notice.

The governor allowed restaurants, beginning June 29, to remain open for dine-in service, but at a capacity not to exceed 50% of total listed indoor occu-

Also notably, the governor ordered rafting and tubing businesses to close and that outdoor gatherings of 100 or more people obtain the approval of local governments before the

While stopping short of issuing a statewide order for Texans to wear nosemasks in public, Abbott did say every Texan "has a re-sponsibility to themselves and their loved ones to wear a mask, wash their hands, stay six feet apart from others in public and stay home if they can." Meanwhile, after news

that the Trump adminis-tration planned to cut funding for COVID-19 testing stations in Texas and other states, Abbott announced that the federal government had granted his request to extend operations of communitybased testing sites across

Texas. The expansion is aimed particularly at Dallas and Houston, where the spread of the deadly, influenza-like disease surged in recent days.

In related news, Abbott issued an executive order on June 25 prohibiting elective surgeries at hospitals in Bexar, Dallas, Harris and Travis counties. The order, intended to make more hospital beds available to potential in-fluxes of COVID-19 pa-tients, directs all hospitals in those counties to post-pone surgeries and procedures that are not immediately, medically necessary.

Cumulative figures posted June 28 by the Texas Department of State Health Services showed some 148,728 COVID-19 cases reported and 2,393 confirmed deaths resulting from the disease in the Lone Star State.

Plans are in place for the Republican Party of Texas to hold its convention July 16-18 at the George R. Brown Convention Center in Houston. Some 6,000 delegates are expected to attend in per-

Conversely, from June 1-6 the Texas Democratic Party held its convention in fully online mode to minimize health risks related to the coronavirus

Study: Impact of military

In a June 22 joint news release with the governor's office, Comptroller Glenn Hegar said the military's impact on the state economy "can be felt by every Texan.'

Paxton cheers SCOTUS

A request by the Texas Democratic party and other plaintiffs to have a San Antonio U.S. district court ruling reinstated that would allow all registered voters to vote by mail instead of in person was denied June 26 by U.S. Supreme Court Justice Samuel Alito.

The action leaves in place an order issued by the U.S. Court of Appeals for the Fifth Circuit, blocking the lower court ruling. Jniversal mail-in ballots, which are notoriously vulnerable to fraud, would only lead to greater election fraud and disenfranchise lawful voters,' Paxton said.

Texas Democratic Party Chair Gilberto Hinojosa said, however: "The case proceeds on in other filings before the U.S. Supreme Court and the Fifth Circuit, and therefore hope remains that the federal courts will restore equal voting rights in time for the November elections.'

The raven nest was the big news this spring

Our neighbor, Joe, who belongs to every social organization in town, found himself with very little to do. So, every afternoon, Joe parked himself in his Adirondack chair and watched the ravens frequently with a cocktail.

"What's going on out there?" Peter asked. After a terrific lot of

noise, the commotion died down. But then, just before sunrise, it started up again and this time it even woke me. It sounded like there was a war happening in the backyard.

"What happened?" Peter wondered. Nothing good for the ravens, that was for sure

There were no more baby ravens screaming for food, no more parents flying back and forth, no more pairs of ravens flying at sunset. The sky was empty-except for hummingbirds, but they don't really

Peter wrote to a friend who used to be an animal control officer in town. He said it could have been a hawk or an eagle or an owl. He said ravens were ferocious fighters and they might have moved the chicks to

AgriLife Extension experts: Time to say 'no' to mosquitoes

By Susan Himes

Mosquitoes carry a host of diseases and viruses that can be dangerous to people, pets and livestock.

Mosquito basics
Male mosquitos feed only on nectar, unlike their blood-sucking counterparts. Females also feed on nectar but need blood for egg production.

There are species of mosquitoes that feed during the day and species that feed at night. That may be why it seems like there are so many mosqui toes out at dawn and dusk - during these periods, the day and night feeders may

overlap.

Mosquitoes are coldblooded and can't regulate their body temperature. That's why on warmer days, they seek shade and why they typically aren't around when the thermometer dips below the mid-50s.

The species of mosquito

that carries West Nile vi-rus typically lives in more urban areas, so people in cities are more likely to contract West Nile virus and need to be aware.

Mosquitoes hibernate in the winter. Some mosquitoes spend their winter as eggs that then hatch when the weather warms up, while others hibernate as adults or larvae. Areas with a hot and humid tropical climate can experience mosquitoes year-round.

Mosquitoes and dis-

Mosquito prevention
The first step in mosquito prevention involves finding and eliminating mosquito breeding grounds. Mosquitoes lay breeding their eggs in or near stand ing water, so any stagnant water is a potential problem. Any place around the home or property where water can collect and sit for seven to 10 days is a problem to address.

Check property for standing water in clogged rain gutters, birdbaths, old tires, children's play equipment, potted plant trays, tarps, holes in trees, bowls and buckets - literally anything that can hold standing water. Make sure to regularly change the water in any pet bowls out-

Dump or drain stagnant water and turn over or cov-er items that catch and hold water. Gravel or sand can be used to fill places where stagnant water col-


