During his remarks, the Governor discussed the incredible advancements that Texas has made that allow the state to open fully and lift the mask mandate-noting the rapid increase of vaccines. Nearly 5.7 million vaccine shots have been administered to Texans, and the state is now administering almost one million shots each week. By next Wednesday, about 7 million shots will have been administered in Texas and over half of seniors in Texas will have received a vaccine shot. By the end of March, every

Highlands

HIGHLANDS - A man was found gunned down in the 100 block Del Monte Lane, near Bluebell Street before 2:50 a.m. Sunday,

the last day of February. Harris County Sheriff's Office District III deputies discovered the victim, who was identified by family members at the scene, lying in the driveway, unresponsive from an apparent gunshot wound.

It appears Rene Hernandez, 53, was shot in his sister's front yard upon returning from a bar unannounced, according to Sergeant Sidney Miller of the Harris County Sheriff's Office Homicide Division.

Highlands Fire Department EMS arrived on the scene and pronounced Hernandez deceased.

Witnesses told deputies of hearing a loud argument then at least two gunshots.

Witnesses say they went outside to see the victim's black Dodge Charger and possibly another vehicle, called to be a black Ford Ranger, flee the scene. The Dodge Charger drove northbound while the Ford  $Ranger\ drove\ south bound.$ The victim's Dodge Charger was later recovered approximately 1 mile from the shooting scene. No description of suspects was

provided by witnesses The Sheriff's Office Homicide and Crime Scene Units were called to the scene to conduct the investigation. The case is currently under investigation and anyone with information is urged to call Crime Stopper at (713) 222-TIPS (8477) or the Harris County Sheriff's Office Homicide Unit at (713) 221-6000.

senior who wants a vaccine should be able to get one. The vaccine supply continues to increase so rapidly that more and more ans will soon be eligible to receive a vaccine.

The Governor noted that Texas has a surplus of personal protective equipment and can perform over 100,000 COVID-19 tests a day. The state has invest ed in a variety of anti-body therapeutic drugs that have kept thousands of Texans out of hospitals. Texans have also adopted daily habits that reduce the risk of COVID-19 exposure and infection. More than 2.5 million Texans who were lab confirmed for COVID-19 have recovered since the beginning of the pandemic, and experts note the total number of Texans who have recovered from COVID-19 is likely 4-5 times that amount. The number of active COVID-19 cases is the lowest since November-meaning more Texans are recovering from COVID-19 than contracting it.
This executive order re-

scinds most of the Governor's earlier executive orders related to COVID-19. Effective next Wednesday, all businesses of any type may open to 100% capacity. Additionally, this order ends the statewide mask mandate in Texas. Businesses may still limit capacity or implement additional safety protocols at

their own discretion.
If COVID-19 hospitalizations in any of the 22 hospital regions in Texas get above 15% of the hospital bed capacity in that region for seven straight days, a County Judge in that region may use COV-ID-19 mitigation strategies. However, County Judges may not impose jail time for not following COV-ID-19 orders nor may any penalties be imposed for failing to wear a face mask. If restrictions are imposed at a County level, those restrictions may not include reducing capacity to less than 50% for any type of entity.



#### Judge Opposed

County Judge Lina Hidalgo issued this statement on the Governor's announcement:

"Taking away critical public health interventions that we know are working won't make our community safer, nor will it hasten our return to normalcy. Quite the opposite, every time public health measures have been pulled back, we've seen a spike in hospitalizations. If we start the climb now, we'd be starting from the highest starting point ever when it comes to our hospital population, an unacceptable and dangerous proposition With the arrival of COVID-19 vaccines, we're inching closer to the finish line of this pandemic - now is not the time to reverse the gains we've worked so hard to achieve.

At best, today's decision is wishful thinking. At worst, it is a cynical attempt to distract Texans from the failures of state oversight of our power grid.



### Current Disaster is Not an "Act Of God" But a Lack Of Action by State Leaders

TMO, The Metropolitan Organization, denounces the lack of state leadership which has produced a desperate and dire situation for Texas families. Cities have nursing homes without electricity, apartments and mobile home parks have no water and power, and whole counties are without shelters or warming stations.

"Ideology, greed, and incompetence at the state level have come together as a perfect storm to threaten the lives of Texas families," said Bob Fleming, TMO leader.

Texas saw similar power and infrastructure failures in 1989 and again in 2011 as a result of similar weather events. Notwithstanding these warnings, state leaders failed to prevent it from happening again.

"The storm may have been an act of nature, but the devastation of the electrical grid shut down is an act of sheer negligence", said Pastor John Ogletree of First Metropolitan Church with TMO. "It was foreseeable based on similar occurrences in the past, and so a failure on the part of state leaders to address the basic energy infrastructure needs of a growing state. There needs to be a full accounting by state leaders as to what happened and what is being done to address this critical need.'

TMO and the Network of Texas IAF Organizations calls on Governor Abbott, Lt. Governor Patrick, and state leaders to immediately supply Texas communities with power, water, food, supplies and emergency shelter.

- Release state funds to local governments for direct assistance in food, water, supplies.
- Work with federal government and FEMA to bring immediate national assistance to Texas.
- Force ERCOT to get service running and ensure that PUC prevents further rate spikes.

Over the long term, TMO calls on state leaders to invest in "winterizing" our power, water, and other utilities to prevent future disaster. TMO leaders demand that state leaders own up to the anti-regulation ideology that has done damage to Texas's infrastructure, and to take action to turn


guys and create jobs fer Americans! Give them pills names people can actual say. "It wouldn't be too awful dang hard to remember a

# Political fallout from Winter Štorm continues

As Texans across the state continue to deal with the damage from the mid-February winter storm, so does the political fallout in

So far, seven of the 16 board members of the Electric Reliability Council of Texas have resigned. CEO Bill Magness defended ERCOT's decision to order widespread blackouts while testifying before a joint hearing of two state House committees last week.

Meanwhile, the Public Utility Commission, which oversees ERCOT, says it has opened an investigation into retail electric providers whose flexible pricing plans inflicted electric bills in the thousands of dollars on some Texas customers in the wake of the storm. In a televised address on Wednesday, Gov. Greg Abbott said he had ordered that Texans will not have their power shut off because of unpaid bills until the Legislature has had time to act. He acknowledged that power generation from all sources failed under the harsh weather, including natural gas, coal, nuclear, wind and solar. Abbott has made it a legislative priority to mandate and fund winterizing the Texas power infrastructure.

However, the head of Irving-based Vistra energy testified at last week's committee hearing that winterizing power plants could backfire in summer months. According to the Texas Standard, Curt Morgan said, "We don't put structures around our equipment down here. Why? Because in the summer when it's 105 degrees you'd bake inside there; the equipment would fail."

Additional hearings are scheduled this week in the Texas Senate.

#### MORE COUNTIES ADDED DECLARATION

The Federal Emergency Management Agency has



added an additional 31 Texas counties to the federal disaster declaration, making a total of 108 counties covered. Abbott originally asked that all 254 Texas counties be included. Texans across the state are urged to fill out a form to help the state identify damages that occurred during the storm, which can be accessed at: https:// tdem.texas.gov/ warming-

Push to expand broadband continues

The latest issue of Fiscal Notes from the state comptroller's office provides a comprehensive look at the issue of expanding broadband, which Abbott made an emergency legislative priority item in ear-February.

COVID-19 pandemic accelerated demand for broadband Internet service as

schools went virtual and telemedicine became more common. As of January, educators had paid for more than 4.5 million broadband devices and Wi-Fi hotspots, using funds from the Texas Education Agency, local school dis-tricts, businesses and fed-

eral funding. A bipartisan group of 88 Texas legislators in November recommended that the state create a compre-hensive broadband plan and establish a state broadband office. Jennifer Harris is state program director of Connected Nation Texas, which partners with private and public entities to push for expansion of broadband. She noted, "The pandemic has shown everyone how important broadband is. Ten years ago, we had to tell people why broadband would be good for the community. We don't need to tell anyone that anymore.'

#### AFTER STORM, COVID-19 VACCINES RAMP UP AGAIN Nearly 700,000 first

doses of the COVID-19 vac-cine are coming to Texas this week, with 429,600 second doses arriving as well, according to the Tex-as Department of State Health Services. Providers quickly resumed vaccinations after power and water service were restored across the state. The state continues to provide shots for health-care workers long-term facility residents, people over 65 and those with existing medical conditions. TDSHS says vaccines are limited to the capacity of vaccine manufacturers to produce them, and there is not enough vaccine to supply

every provider every week. The Centers for Disease Control this week is ship-ping doses to 522 providers in 199 counties. As of Sunday, 3.4 million Texans had received the first dose and 1 728 million were ful lv vaccinated, according to TDSHS. More than 40% of adults 65 years and older have received the first dose, and nearly 20% in that age group are fully vaccinated.

#### COVID-19 CASES, DEATHS UP FROM PREVIOUS WEEK

The winter storm likely muddied last week's reporting, but new cases of COVID-19 in Texas totaled 55,547 in the last week according to the Coronavirus Resource Center at Johns Hopkins University of Medicine. A total of 1,478 deaths were reported. Both figures are considerably higher than what was reported the previous week, but that could be a result of delayed data due to the storm. A better comparison can be made next week, with two weeks of relatively normal weather conditions. Regardless, health officials across the state are still urging Texans to wear masks in public, practice social distancing and wash our hands frequently.

So, the next day, we called up Shelley. She had just gotten home from a dental appointment and had a sore

I held my breath, but I didn't have to wait long. "OK!" she said.

And, yes, it is more than a year and a half away, but it still feels wonderful to have a plan to go somewhere other than the gro-cery store. Just thinking about seeing a new landscape fills me with excite-

Later in the day, I went for the hike I take every aftermoon It seems as if I've seen every tree along the way, noticed every rock, and as I walked, I thought how nice it would be to hike in completely unfamiliar surroundings.

But just as I was thinking this, I stopped and looked at the tree directly in front of me, caught in the afternoon light. I don't remember ever really looking at it before. It's a beautiful tree, in a forest of beautiful trees, and I have walked by it thousands of times without giving it a second look.



Vaccine supplies are still limited, so only people in the 1A or 1B groups are eligible - health care workers, people over 65 or those with chronic underlying health conditions.

For people who can't be vaccinated yet, get tested! Four in 10 people who have COVID-19 don't know it because they don't

still contagious. The more people who get tested and vaccinated. the faster we can stop the spread of COVID-19 in our community.

# Two Storage Unit burglars nabbed by joint work of Sheriffs in Liberty and Chambers County

Chambers County Sheriff's Office became aware that a beaten up, nearly broke down, nasty Dodge truck was cavorting a male and possibly a female burglary pair to break into local storage bins last month but on February 19 Sheriff Hawthorne ruined that gig with detective work.

The suspects hooked up a cargo trailer with an attached generator that was inside the storage unit to their Dodge truck, as well as an orange/black

go-cart inside the trailer before leaving the scene. No doubt the couple was thrilled with the multiple vehicle get away.

Chambers County law enforcement launched a joint effort and investiga-

tion. Detective Jacobs discovered that the Liberty County Sheriff's Office had located the suspect vehicle, pulling the stolen trailer, within their jurisdiction. The white female and white male were still in the

Once Liberty County Deputies effected the traffic stop, the occupants were identified as Carey Lvnn Moore, 53, and Michael Anthony Kitchen, 44. # Senator Creighton files 4 bills in 87th Legislature

Deal with 2nd Amendment, Emergency Alert, Fraud Protection, and Buy American

Austin, Texas-Senator Brandon Creighton (R-Conroe) has filed several bills, including legislation assisting school marshals, cementing Texans 2nd Amendment rights during disasters, safeguards for Lone Star cards, and an expansion of his signature 'Buy American' policy for Texas colleges and univer-

"These 4 bills are part of my legislative package that spans election integrity to tax reform, 2nd Amendment rights to flood infrastructure projects, targeted investments in higher education for a skilled workforce, securing the border, and reform and consequences from last month's freeze and blackouts," said Senator Creighton. "The work is well underway, and I won't stop until we have delivered

bold solutions and conservative results for Texans."

Second Amendment **Protections During Di**sasters: SB 18 has been identified as a Top 30 priority for Lt. Gov. Dan Patrick, and is backed by the National Rifle Association. The bill establishes that firearms and ammu-

nition manufacturers, distributors, wholesalers, suppliers and retailers are essential businesses that shall not be prohibited by state or local officials from operating during a declared disaster or emergency. This bill prevents any future infringements, ensuring that guns and ammunition will never be limited during disaster, further cementing that Texas is the freest and safest state in the nation

Buy America: SB 783 expands Senator Creighton's signature 'Buy America' legislation that he passed in the 85th Legislative Session (SB 1289). Currently, the law requires large state projects to purchase iron and steel from an American supplier if the cost doesn't exceed 20 percent more than the

price of cheaper, foreign imports. Building on the success of SB1289 this bill expands the requirement to Texas public colleges and universities, ensuring large projects that are funded with taxpayer dollars support American jobs and companies.

Statewide Disaster

Alert: SB 865 will study the efficacy, benefits and implementation of a statewide disaster alert system. This bill is in response to last month's severe weather, where communications failures throughout the state were exposed. Similar to an Amber Alert, Texans will receive notifications on their phones warning them of severe weather, giving them the tools to plan and prepare. When completed, if the study shows that it

can be done effectively, the Lieutenant Governor and Governor can approve the new alert system, and then work with local governments to choose to partici-

Fraud Prevention: SB 866 Requires Lone Star Cards to include photo identification of benefit recipients, preventing fraudulent use of the cards, and ensuring TANF and SNAP benefits are being used properly to benefit those in need. There have been cases of Lone Star Cards being sold for cash, and this measure will add extra security and prevent misuse. This bill was filed in the 86th legislative session, but did not ultimately pass.

# Advanced Relief for Hernia Pain

BAYTOWN — (February 12, 2020) — A hernia can trigger immense pain that can become debilitating if left untreated, but living with this pain can be a thing of the past thanks to advanced hernia repair techniques.

A hernia occurs when tissue pushes through an opening in the abdomen (ventral hernia) or groin area (inguinal hernia). Common symptoms include pain in the abdomen when coughing, bending, twisting or lifting objects; a bulge or lump in the abdomen or groin; heaviness, weakness or dull pain in the groin or abdomen; nausea, vomiting or both; and an inability to have a bowel movement or pass gas.

Dr. Robert Ochoa, a critical care/general surgeon with Houston Methodist Baytown Hospital, says there are many possible causes of hernias.

"Hernias may be caused by a variety of factors, including congenital defects, age, chronic coughing, damage from injury or surgery, or lifting heavy objects. Pregnant women may be susceptible to hernia due to the pressure placed on the abdomen,' Ochoa said.

While many people attempt to deal with a hernia by putting up with the pain, the agony often becomes too much to bear and begins to negatively affect their daily life. Ochoa utilizes robot-assisted, minimally invasive surgical procedures to repair hernias and eliminate Robotic-assisted sur-

gery gives surgeons the ability to utilize the pinpoint accuracy of the device's robotic arms, as well as a 3-D view of the surgical area and increased magnification, to perform minimally invasive surgeries that produce small incisions, less post-surgical pain and quicker recovery times

"The system gives sur geons a magnified, 3-D view of the incision site and allows us to control multiple robotic arms for more precise movements, Ochoa said. "In the past, these procedures required open surgery, which resulted in larger incisions, increased pain and a longer recovery."

Robotic-assisted surgery-Houston Methodist. Baytown Hospital surgeons use the da Vinci Surgical Robotic



System-allows the surgeon to operate from a console while viewing a three-dimensional image of the surgical field. It translates the surgeon's hand, wrist and finger movements into precise movements of tiny surgical instruments inside the patient's body. It allows surgeons to perform minimally invasive laparoscopic—surgery that uses a thin, lighted tube inserted through very small in $cisions - \overline{procedures}.\\$ 

"The system increases the degree of freedom ergonomically because now you have multiple instruments functioning as your hands," Ochoa said. "It allows us to perform major surgeries through dime-

sized incisions. The system's camera allows me to see things I normally wouldn't be able to."

Other benefits of robotic-assisted procedures include less post-surgical pain, lower risk of infection; reduced loss of blood, which reduces the need for transfusion during surgery; and a shorter hospital stay.
