COVID vaccination now available without wait

Get Vaccinated at NRG Park Without an Appointment

HOUSTON – Effective immediately, anyone in Harris County or the greater Houston area will be able to receive the COV-ID-19 two-dose Pfizer vaccine at the FEMA Community Vaccination Center (CVC) at NRG Park with or without an appointment. Additionally, starting Wednesday, April 21, the CVC hours of operations are changing from 8 am to 5 pm to 12pm – 9pm to make it easier and more

convenient for residents to get the vaccine. Although it is preferred

for residents to register as $% \left\{ 1,2,...,n\right\}$ it guarantees a vaccine is available at a time and location of their choice, people can show up, driving or on foot, at the NRG Park CVC to get vaccinated. Residents walking in or driving up into NRG Park without an appointment should enter via Gate 16A off of Main Street. Staff working the site are ready to receive and assist residents when they arrive. Residents can visit ReadyHarris.org, vacstrac.hctx.net or call the HCPH Vaccine hotline at 832-927-8787 for assistance. With the recent registration changes, residents who sign up for a vaccine from Harris County Public Health (HCPH) are now given appointment at all HCPH vaccination sites immediately after registering for a vac-

cine, while supplies last. Harris County reiterates its commitment to providing vaccines efficiently, fairly and equitably by eliminating barriers to registration and providing information in multiple languages online and via phone. Waste Pits delayed another 270 days

Remediation work may not start until 2024

NO TIME TO WASTE: A Call for Inclusivity and Transparency in the San Jacinto River Waste Pits Superfund Process.

HOUSTON – Jackie Young Medcalf, president of the Texas Health & Environment Alliance (THEA) recently learned that the U.S. Environmental Protection Agency (EPA) authorized a 270-day extension to the design phase of the San Jacinto River Waste Pits Superfund process at the request of the responsible parties (International Paper and Waste Management subsidiary, McGinnis Industrial Maintenance Corporation). This extension is on the heels of a 160-day extension authorized by the EPA in September of 2020.

Medcalf feels that the EPA needs to be more transparent and inclusive in these types of decisions. She feels the first extension allowed time for more testing and sampling, but thinks the new extension will just be an unnecessary delay and have the potential problem of moving remediation work back several years and conflict with a new I-10 bridge that TxDOT plans to build over the San Jacinto River.

The Waste Pits Superfund Site is the result of paper mill waste disposed of along the San Jacinto River in the 1960s. The Waste Pits presented such a threat to the environment and to public health that they were listed for clean-up under the

EPA Federal Superfund program in 2008. Currently, remediation of the Waste Pits is in the design phase which was initiated in April of 2018 by a settlement between the EPA and the Waste Pits' responsible parties.

When the 160-day extension was authorized in 2020, THEA did not object to this allowance for further sampling and water treatability studies. Unfortunately, the EPA did not effectively utilize this time and require the responsible parties move swiftly on sampling. This misuse of time is unacceptable to local community members and it is critical that the EPA stop allowing time to be wasted and require expedient and thorough work be completed. Delays or poorly executed work may pose public health and environmental consequences in

surrounding communities for generations to come.

The EPA has ultimate authority and oversight to see that the Waste Pits are removed in a reasonable timeframe and with best management practices to ensure a safe and efficient clean-up. The local community has been left in the dark while time has been wasted.

Scenes from San Jacinto Battle reenactment



Sam Houston leads his army in retreat eastward carrying the Twin Sisters a gift from Cincinnati, Ohio to the cause of human liberty, in an effort to stay active and await a mistake by Santa Anna.



At about 4:00 p.m. April 21, 1836, having cut off the Mexican Army from more reinforcements the Texian Army attacked Santa Anna's larger force by surprise sneaking up through 5 foot tall grass until they fell upon the garrison in two proposes.



In about 20 minutes the Mexican resistance was subdued but the killing continued throughout the afternoon. About 750 Mexican Army were killed, 4 Texians died during the battle with 3 more were to die soon thereafter of wounds. That number nearly included General Sam Houston hit in the ankle by a .78 caliber ball.



Santa Anna in a private's uniform was identified when he was brought before a wounded Houston but all of the Mexican troops saluted and called out "El Presidente." Houston dealt to secure what would become more than 1/4 of the continental U.S.A. and sent Santa Anna to meet President Andy Jackson. Jackson snubbed Santa Anna de Lopez. Patriots put Houston on a ship to New Orleans where he almost died reaching much needed medical attention.

Joining Forces for Our Children

Message from Sheriff Ed Gonzalez

Earlier this week, we kicked off Child Abuse Prevention Month at the steps of The Children's Assessment Center with our most dedicated partners in the fight against child abuse in Harris County.

As a close-knit community of child advocates, we work as a team to protect our most vulnerable.

You are part of this team. We rely on our community to report abuse and keep our children safe when they see the signs of a child in need.



Blue and silver pinwheels outside The Children's Assessment Center building were spinning in the wind, one for each of the 175 children who are victims of abuse in Texas every day.

Signs of abuse aren't always obvious, but they are often there if you know where to look. We are asking every adult in our community to help. Take actionable steps to create safer environments for the children in your life:

If you see something, say something. Reporting suspicions of child abuse can save a life, prevent further victimization, or stop more children from being victimized.

Learn how to recognize and report child abuse. Education and training are our best defense against those who harm children.

Talk to your children. Start the conversation _early and continue the discussion throughout their upbringing.

Spread the message. Tell your neighbors and loved ones how they, too, can do their part to keep our children safe in a real and virtual world.

Our partners at The CAC offer free training and resources on the signs and symptoms of child abuse and share stories of survivors throughout the year. In April, they're hosting additional training and virtual workshops on child abuse awareness and prevention. For more information on what's in store and how to get involved, click here.

As first responders, we work tirelessly to investigate allegations of child abuse. We also work hard to identify and combat human trafficking cases, especially those involving a juvenile.

There aren't many jobs in our agency that are tougher than being a child abuse investigator. These incidents are horrific, heartbreaking cases of abuse and neglect involving an innocent and defenseless child.

But it's an important calling that offers the chance to make a difference in the lives of our community's great asset: our children.

Our investigators' role in child abuse cases spans the entire case from the initial call, through the investigation, and to the court proceedings. Our Crimes Against Children Unit stays involved in the investigation as the victim and their family receive the proper treatment, services, and support from advocacy centers to start their healing process. It's a coordinated response from the start.

Sadly, in 2020, nearly 4,000 children received services at The CAC. These experts provide high-quality care so children can thrive. Their work embodies the sentiment: "No future should be out of reach."

And while the work of our specialized unit is always essential, it is especially critical during a crisis. The disruption brought on by the pandemic made our children even more vulnerable to abuse. Some of those traditional safety nets have been removed with children not regularly attending schools, daycares, and after-school programs.


With violent crime on the rise over the past year, Harris County is investing in overtime pay meant to help our investigators target violent criminals in several key areas, including tackling child abuse investigations.

NEW PUC COMMISSIONER CONFIRMED

Will McAdams, nominated by Gov. Greg Abbott to a slot on the Public Utilities Commission, was unanimously confirmed by the Texas Senate last week.

McAdams formerly served as president of the Associated Builders and Contractors of Texas and worked for legislators for more than a decade in various senior staff positions.

Abbott has also nominated Peter Lake to be the new chair of the PUC, which regulates the state's power grid operations. Lake now serves as chair of the Texas Water Development Board.

All three previous PUC members resigned after February's winter storm led to massive power outages across the state.

HOUSE PASSES BILL TO ALLOW HANDGUN CARRY WITHOUT A LICENSE

The Texas House voted 87-58 last week to allow handguns to be carried without a permit. Under current law, a permit is required to carry handguns either concealed or openly. If the bill becomes law, any Texas resident not already prohibited by state or federal law from owning a gun could

STATE HALTS DISTRIBUTION OF J&J VACCINES

August 2019.

Use of the single-shot Johnson & Johnson & Johnson COVID-19 vaccines has been temporarily halted in Texas following a recommendation last week from the Centers for Disease Control and the Food and Drug Administration.

The Texas Department of State Health Services issued the notice following extremely isolated reports of blood clots in a half-dozen recipients of the J&J vaccine — all in women between the ages of 18 and 48, according to the CDC.

As of April 12, more than 6.8 million doses of the J&J vaccine have been administered in the United States. There is no word of when the

vaccine might be used again.

NUMBER OF TEXANS

VACCINATED EDGING TOWARD 50%; CASES STEADY

Even with the halt in distribution of the J&J vaccine, the number of Texans who have received at least one dose of the Pfizer or Moderna two-shot vaccines hit 44.5% as of Sunday, according to DSHS.

A total of 6.37 million Texans are fully vaccinated — roughly 20% of the state's population. Texas is receiving more than 1.9 million doses of COVID-19 vaccine this week.

The number of new COVID-19 cases in Texas last week dropped slightly from the previous week at 23,521, while deaths dropped to 374, a decrease of 27%, according to the Coronavirus Resource Center at Johns Hopkins University.

JOBLESS RATE UNCHANGED AT 6.9%

The state's unemployment in March remained steady at 6.9%, with the state adding 99,000 total nonagricultural jobs, according to the Texas

Workforce Commission.

"Positive job numbers for March continue to show Texas is on track for continued growth," TWC Chairman Bryan Daniel said. "TWC will continue to provide flexible and innovative training programs to help provide all Texans with skills they can use for workforce success."

The 6.9% rate is more than double the state's record low of 3.4% in May 2019. Jobless claims have risen since the mid-February storm, and the state has lost more than 400,000 jobs since the pandemic began early last year, according to the federal Bureau of Labor Statistics.

FEMA EXTENDS REGISTRATION FOR STORM DAMAGE CLAIMS

The Federal Emergency Management Agency has extended the registration period for individuals whose property was damaged in the winter storm until May 20 in the 126 qualifying Texas counties. The state's emergency management agency made the extension request.

Individuals can apply online at www.disasterassistance.gov or by calling 800-621-3362. The toll-free line is operated from 6 a.m. to 10 p.m. seven days a week.



The Last Box

"Oh my gosh. I don't want to open that box." Moving furniture and books and clothing is easy. It's moving memories that is

I am going through the last of my boxes. I used to say I was not a packrat. I thought I was more like my mother than my dad. My dad might tuck a piece of wood away, thinking it would find a use someday. My mother would be of the opinion that it's easier to buy a board when (and if) it was needed. Generally, it wasn't.

This approach keeps my parents' house very tidy with the possible exception of one small room in the basement where my dad keeps his wood collection.

keeps his wood collection. It turns out, I am not at all like my mother.

I have filed things away that will never find any purpose whatsoever other than to remind me of things I did and used to care about that I no longer do. For the last few days, I've been emptying the box.

Photos from when we used to take real photos, letters from people who cared about me, certificates indicating I accomplished something or another, reviews that mentioned my name, currency from foreign countries I will never visit again, 100+-year-old spectacles (why?), a lovely handheld fan my former mother-in-law gave me, clever things I wrote when I was in the fifth grade (really?), recipes in my grandmother's handwriting, and even (I am embarrassed to admit) my old teddy bear.

My teddy bear feels crunchy. His exterior is badly corroded by time, I can't imagine what has happened to his insides.

All of it is in the last box, waiting to be emptied.
Some of it is easy to understand wanting to hang onto. I am scanning some of the photos and my grandmother's recipes, and they will move onto the great cloud in the sky. (That is

cloud in the sky. (That is where I imagine the cloud, not being savvy with computer matters.) They will likely get no more attention on the cloud than they did in the box, but they will gather less dust and—most importantly—they won't need to be moved.

But still I worry that some of this—some potshard from my past—will be needed. It will be necessary to remember something I did or someone I knew or something that was important to me and, if I lose it, I will lose some part of myself.

The fact that this is nonsense does not lessen the feeling.
I've heard the mantra

I've heard the mantra that we should keep only what "sparks joy," and I cannot claim that anything in that box is sparking joy. In fact, the existence of that box is causing me a fair amount of angst.

Instead, I ask myself,

"Would I experience great pain if I threw this away?" Generally, the answer is,

"No," and the item is tossed. But sometimes, for no logical reason, I hold something in my hand, and I feel I need it. I need the fan my mother-in-law gave me, I need those 100+-year-old spectacles and, yes, it is possible that I might still need my teddy bear—even though he has gone all crunchy on me. Heck, I've gotten a little crunchy myself.

It's not a perfect system. But the contents of the box are shrinking and the guilt for hanging onto so much stuff is dissolving, and I feel a sense of satisfaction, sending one after another of my grandmother's recipes through the scanner.

I just found her recipe for chocolate frosting. I'm going to make it sometime soon.

Problems are best solved with open and transparent communication - which we are lacking for this Superfund Site. It is our impression that the EPA has allowed the focus to be on a singular concept created by the responsible parties. These are the same parties who made their agenda clear for this site - they wanted to leave the Waste Pits in the San Jacinto River and were forced by federal order to cooperate in this process and to fully remove the Pits.

The EPA must hold polluters accountable and must provide transparent communication to the community. The tension is mounting for local residents and with every hurricane season that approaches, fears heighten of the Pits being further disrupted by Mother Nature. Considering the 270day extension and procurement time for remedial equipment, this pushes the estimated clean-up start to 2024. The Waste Pits are nestled to the immediate north and south of Interstate 10, which Texas Department of Transportation (TX-DOT) plans to replace starting in the Spring of 2025. Unfortunately, it was announced in 2020 that the remedial timeline adjusted from 2 years to 7 years. Local residents are extremely concerned about how these two major

projects will impact one another, and how barge traffic on the River will impact the safety of these efforts. We need to see interagency coordination on these sensitive efforts taking place in the same timeframe, adjacent to one another on the navigable waterway.

The community and our elected officials need to hear from the EPA. We need to be informed and included in the process taking place that not only affects the future of Interstate 10, but the health and safety of the community and Galveston Bay.

DIOXIN AND THE

ENVIRONMENT We know that dioxin is extremely toxic and that it can hold its toxicity for hundreds of years. We know it is present in extremely large quantities in the Waste Pits and that the most recent testing of the river surface water showed high levels of dioxin in the water column. And we know that rates of cancer in children are elevated in the communities surrounding the Waste Pits. We must stop wasting time. Our children have rates of rare eve cancer over 16x the state average. Our seafood is contaminated. Another hurricane season is quickly approaching. As long as the Pits are in the river, far too much is at stake

The Texas Health and

Environment Alliance's mission is to protect the environment and public health from the harmful effects of toxic waste. We endeavor to establish an informed and engaged public movement to restore and protect environmental resources from historical contamination.

ABOUT THE SAN JA-CINTO WASTE PITS/CO-ALITION

For many years, the Waste Pits along the San Jacinto River were a hidden crisis posing great danger to nearby communities. The abandoned, dioxin-filled pits threatened local seafood and the river for decades. In 2015 the Texas Department of State Health Services confirmed elevated rates of cancer in children and people of all ages living near the Pits. THEA's San Jacinto River Coalition, which is a community led group working to educate the public about the San Jacinto River Waste Pits Superfund Site, was successful at urging the EPA to fully remediate the site.

On October 11, 2017, the EPA signed a Record of Decision for remediation of the San Jacinto River Waste Pits. In addition to installing energizing controls like a cofferdam, the plan includes directives for the removal of dioxin-contaminated material down to a recreational standard of 30 parts per trillion.

Driver License waiver has now ended

AUSTIN – The COVIDrelated waiver on expiration dates for driver licenses (DLs) and identification cards (IDs) has now ended. The Texas Department of Public Safety (DPS) continues to urge customers with an expired DL or ID to make an appointment or renew online

To assist customers with expired licenses who were unable to schedule an appointment prior to the waiver ending, DPS implemented a new procedure allowing them to request a temporary driving permit that will remain valid until their appointment date. For additional details on that process, please visit the DPS website.

The expiration waiver, originally granted by Governor Greg Abbott in March 2020 due to the COVID-19 pandemic, applied to DLs, commercial DLs, commercial learner permits, ID cards and election identification certificates that expired on or after March 13, 2020.

Driving with an ex-

pired license

The department cannot determine what action a law enforcement officer or the court may take if someone is stopped while driving with an expired license as both have discretion in these matters. That is why the department continues to encourage anyone with an expired DL to make a renewal appointment now and apply for the temporary driving permit in order to stay in compliance.

Renewing online remains a convenient option

ble to skip the trip to the office entirely by renewing their DL or ID card or changing their address on-line at Texas.gov. As of April 1, 2021, there were approximately 858,000 expired driver licenses in the DPS system. Of those, roughly 130,700 are eligible to renew online. Customers can also renew by phone at 1-866-DL-RE-NEW (1-866-357-3639). The requirements and cost for online and phone renewal are the same as inperson transactions. (When you schedule an appointment, you will be no tified if you are eligible to renew online.)

To assist customers needing in-office DL services, designated high-volume offering expanded hours from 7 a.m. to 7 p.m. Monday through Thursday, and 7 a.m. to 5:30 p.m. Friday.

A reminder that all services at driver license offices are now conducted by appointment only. To schedule an appointment or check availability, visit the online appointment scheduler. If you are unable to find an appointment at the office of your choice, check back for availability at that office or other locations nearby. Please check often as availability does change.

If you are unable to make your scheduled appointment, please reschedule or cancel ahead of time. While the department is working to serve as many

customers as possible, people not showing up for their appointments continues to be a major obstacle. In March 2021, for example, approximately 28% of people (or more than 198,000 customers) were no-shows for their appoint-

The appointment system, which debuted in May 2020, is designed to provide additional convenience, reducing the time Texans wait in line. Customers can book appointments for a specific day and time, up to six months in advance, and show up 30 minutes or less before their scheduled time. Customers can check-in using the kiosk inside the office or from their mobile device.


All offices offer a limit-

Additionally, most offices may be able to offer some customers without an appointment a spot on a "standby" list. The number of standby appointments available is limited to ensure all customers who are placed on the list will be served by the end of the day.



maximum guaranteed price put forth by bidders, members of Commissioners Court also voted to award the bid pertaining to the construction of the proposed West Side Complex to Brookstone Construction Managers and General Contractors.

This award and vote to move forward does not guarantee the CO. however. There is still a multi-step process which must be completed before the CO is officially issued. Several public comment periods will be held so that the public has ample opportunity to voice their opinion regarding this matter.

Dayton murder remains mystery

was arrested and charged in the fatal shooting of her father inside his Dayton home on the early morning of April 14

Detectives report that Lauren Gayle Prather, 35, of Waskom, was arrested at a relative's home in Crosby hours after the shooting although no motive has been reported by Liberty Countv Sheriff's Office. However, a weapon was recovered. She was taken to Liberty County Jail.

A 911 call from Huff's son at about 7:15 a m dispatched Liberty County Sheriff's Deputies to the home of Dennis Claude Huff, 62, in the 100 block of County Road 6507. He told dispatchers that his sister had just shot their father inside the home.

Deputies found convincing evidence of violence before going inside the home, peering through a window and once inside discovered Huff's body on a couch. Evidently, a head wound had caused a massive

Liberty County Precinct Four Justice of the Peace Judge Larry Wilburn conducted the inquest and has ordered an autopsy the release said.
