HOUSTON - The Texas Department of Transportation will begin making repairs to a portion of the Fred Hartman bridge this weekend. During a routine inspection last year, crews found some fractures along the ioint and immediately repaired the joint with steel plates and later asphalt.

The \$2.5 million emergency contract was approved to replace the modular joint. It took about six months to design and fabricate.

In order to replace the joint on the southbound portion of the bridge, crews will close all southbound mainlanes on the Fred Hartman bridge and then



close the northbound mainlanes the following weekend.

During construction, lanes will be placed in a contraflow configuration to allow for two southbound and two northbound travel lanes on the northbound

-- Beginning Friday, July 9 at 9 p.m. crews will close one left lane on SH 225 from Sens Rd. to SH 146 to prepare the lanes for contraflow. This

closure will last until the project's completion. -- Beginning Friday, July 16 at 9 p.m. until Monday, July 19 at 5 a.m. crews will close the SH 146  $\,$ northbound mainlanes at SH 225 to implement the  $temporary\ contraflow\ traf$ fic pattern and place the

temporary barrier. Motorists traveling northbound will detour to SH 146 north to SH 225

-- Beginning Friday, July 23 at 9 p.m. until Monday, July 26 at 5 a.m. crews will close the SH 146 southbound mainlanes at Missouri St.

Motorists traveling southbound will detour to SH 146 south to Spur 330 north to IH 10 west to IH 610 south to SH 225 east.

It is recommended that motorists seek an alternate route during the time of these closures

On July 26 at 5 a.m. traffic will open to a reduced contraflow pattern and remain for the duration of the project, about two months.

## Mammograms Offer Defense Against Breast Cancer

BAYTOWN — (May 28, 2021) - While many breast cancer statistics paint an upsetting picture of the disease-for example, the American Cancer Society (ACS) estimates more than 281,000 women in the U.S. will be diagnosed with breast cancer in 2021—there's at least one very positive number: over 3.8 million women have had a history of breast cancer and are now 'survivors

The ACS reports that the number of breast cancer survivors is expected to continue on an upward trend thanks in large part to the effectiveness of preventive measures, esperegular mammography, in detecting the disease in its earli-

est stages. Mammograms can detect breast cancer in its early stages, up to two years before a lump can be felt. Early detection means a better chance of a cure and mammography is the

most effective tool available in diagnosing breast cancer at an early stage.

Patients at the Houston Methodist Breast Care Center at Baytown have access to the technological advances provided by 3D mammography, or digital breast tomosynthesis (DBT), which separates the layers of the overlapping tissue and improves the ability of breast radiologists to find early can-

"Women should have vearly mammograms beginning at age 40-or younger if you have a familv history-and should encourage their friends and family to have them as well," said Dr. Esther Dubrovsky, breast surgeon at Houston Methodist Breast Care Center at Baytown.

Dubrovsky adds that women of all ages should regularly self-check their breasts to detect any noticeable lumps or changes in the tissue. Lifestyle changes, such as being

physically active, maintaining a healthy weight, limiting alcohol consumption and reducing stress, may also play a positive role in breast cancer prevention.

"You are the first line of defense when it comes to breast cancer. That's why it's crucial to know how your breasts normally look and feel," Dubrovsky said.

Knowing the warning signs will help you recognize when to alert your doctor. Dubrovsky advises seeing your doctor if you

experience any of the fol $lowing \ symptoms \ of \ breast$ cancer, but keep in mind that most breast lumps aren't cancer:

- · A painless lump or mass in or near the breast · A change in breast size or firmness
- Breast skin changes. such as dimpling, a sore or a rash
- Nipple itching, burning, rash, turning inward or discharge A warm area in the
- breast • Pain in the breast
- Swelling under the armpit or of the arm
- Bone pain

Houston Methodist Baytown Hospital screens all patients, ensuring only those without COVID-19 symptoms are seen in the office. Masks and personal protective equipment (PPE) are required while providing patient care, and we have reorganized waiting rooms and check-in lines to ensure social distancing. We have also implemented additional sanitation processes to disinfect all equipment and surfaces.

Houston Methodist Baytown is designated as a COVID-19 vaccine hub. Vaccines are open to everyone age 16 and older. Walk-ins are welcome, but you may also schedule an appointment by visiting houstonmethodist.org/vac-

### Statement on Failed Quorum in Special Session

The League of Women Voters of Texas president, Grace Chimene, issued the following statement in response to the failed legislative process that drove some legislators to leave Texas today.

"As a non-partisan organization whose mission is empowering voters and defending democracy, the League is deeply disappointed that only extreme measures like the legislative exodus we saw today can prevent Texans from losing their voting rights.

"During the regular legislative session, the League of Women Voters of Texas (LWVTX) partnered with local, state, and national organizations to provide input to legislators who were considering various election bills. Yet, when SB 7 emerged as the final, comprehensive election bill, it was clear that voting rights were under attack. Under the guise of making elections more secure, SB 7 threatened the very core of our right to cast a ballot.

"When Governor Abbott called a special session to again consider elections, two comprehensive bills emerged: SB 1 in the Senate and HB 3 in the House. Yet again, these bills are intended to make voting more complicated and create more potential pitfalls that would deny the freedom to

"Many legislators are not listening. Although over 400 individuals registered to testify on each of these bills, most were not called to testify until after midnight! Where is the meaningful public input? How can constituents trust that their rights are being protected when they are being shut out of the legislative process? If our representatives are truly to represent our interests, they need to listen to us and provide meaningful opportunities to hear us.

"SB 1 and HB 3 would prevent many of us from making our voices heard. Given the challenges to voting in several states including Texas, the League of Women Voters of Texas believes that the For the People Act and the John Lewis Voting Rights Advancement Act are necessary to preserve an election system that is free, fair, and accessible to all.

The League of Women Voters is one of America's oldest and most trusted civic nonprofit organizations. Formed in 1919, the Texas League represents more than 13,500 grassroots advocates and 34 local Leagues across the state. The League never supports or opposes candidates for office or political parties. The League encourages the informed and active participation of citizens in government. The League also seeks to influence public policy through education and advocacy. Membership is open to people 16 years and older.

# Texas Legislature returns for a Special Session

The Texas Legislature convened in special session last Thursday and GOP legislators introduced a fresh set of voting bills after Democrats blocked an earlier attempt during the regular session by walking out in May, preventing a

HB3 and SB 1 don't include some of the more con-troversial measures that were in the previous bill, such as restricting voting on Sundays. KUT.org re ported the new bills include new ID requirements for people voting by mail and banning local election officials from sending voteby-mail applications that have not been requested by the applicant.

The measures, still largely opposed by Democrats and voting rights groups, also ban drivethrough voting and ex-tended hours during early voting. Those backing the new bills say those extended hours encourage voter fraud, though there is no evident of widespread fraud during the 2020 elec tion. Republican lawmakers are pushing for a full House floor vote this week.

Gov. Greg Abbott announced the topics to be considered during the spe cial session the day before it opened. Besides the voting bills, they include:

- Bail reform to "protect the public from accused criminals who may be released on bail."

  • Border security with
- increased funding to support law-enforcement agencies and counties. • Social media censor
- ship legislation to protect social-media users from being silenced by social media companies based on their viewpoints.
- Restoring funding to the Legislature and legislative agencies that was vetoed by Abbott after the walkout.
- Family violence prevention legislation to pro-vide funding for education to middle school and high school students about dat



lence and child abuses. Parents would have the right to opt their children out of such programs.
• Youth sports mea-

- sures to revive legislation passed by the Senate that bans transgender students from participating in UIL athletic competitions "designated for the sex opposite to the student's sex at
- · Abortion-inducing drugs legislation that would prohibit providing such drugs by mail or delivery service.
- Thirteenth Check legislation to allow a one-time supplemental payment of benefits under the Teacher Retirement System of
- · Bills targeting "critical race theory" and restricting how current events and the country's history of racism is taught in Texas public schools
- Appropriation bills targeting property-tax re-lief, protecting children in the state's foster-care sys tem and safeguarding the state from potential cybersecurity threats

#### **PUC ORDERED TO IMPROVE** ELECTRIC RELIABILITY

Abbott also last week directed the Public Utility Commission to make major changes "to ensure the reliability of the Texas power grid," the Houston Chronicle and other media outlets reported.

Abbott asked the PUC,

which oversees the Electric Reliability Council of Texas, to improve mainte-nance on power plants and speed development of some transmission projects

The objective of these directives is to ensure that all Texans have access to reliable, safe, and affordable power," Abbott wrote in a letter released last Tuesday.

In response, PUC chair-man Peter Lake in a letter Abbott expressed "wholehearted agreement with its contents." Besides the widespread blackout during the mid-February storm, a heat wave in June prompted ERCOT, which maintains the state's electric grid, to urge Texans to conserve electricity as usage approached peak capacity.

#### \$4.1 BILLION MORE IN **SCHOOL STIMULUS FUNDS**

Texas will receive another \$4.1 billion in federal stimulus funding for its public schools, the San Antonio Express-News reported.

The U.S. Department of Education announced last week that it had approved the state's plans for spending \$12.4 billion that was allocated to the state. According to the Express-News, the top priority for the Texas Education Agency is bolstering the mental and emotional health needs of Texas students by expanding tutoring and

other methods.
TEA estimates Texas students lost 5.7 months of earning during the pan-

demic school year.
"The approval of these plans enables states to reeive vital, additional American Řescue Plan funds to quickly and safe-ly reopen schools for fulltime, in-person learning; meet students' academic, social, emotional, and men tal health needs; and address disparities in access to educational opportunity that were exacerbated by the coronavirus pandemic," Secretary of Education Miguel Cardona said in a news release.

#### **NUMBER OF COVID-19 CASES IN STATE RISES**

At 12,426, the number of new COVID-19 cases in Texas increased 18% in the past week when compared to the previous week, ac-cording to the Coronavirus Resource Center at Johns Hopkins University.

The number of new deaths in the past week dropped slightly to 151. Hospitalizations of lab-confirmed COVID-19 patients in the state were on the rise, with 1,927 currently in Texas hospitals as of Sunday, according to Texas Department of State Health Services.

The number of Texans fully vaccinated crossed the 12 million mark this week, DSHS reported. The rate of vaccinations in the state has slowed significantly in recent weeks, despite troubling reports of the spread of the delta variant of COVID-19.



#### Lost in the Move



# Homeowner faces murder charges

HIGHLANDS - Even if you say the right words, Harris County Sheriff's office still investigates deadly shootings, as evidenced by details gathered from their media relations.

At about lunch time on April 12, a man called 911 saying a man was acting crazy and had come in his house without consent, refusing to leave. Harris County Sheriff's Office District 3 Patrol Units were dispatched to 910 Jones Rd. in reference to a disturbance

According to Homicide Sergeant Dennis Wolfford, "While deputies were en route

to the residence, the homeowner shot the male. Deputies and EMS arrived on scene and the male was pronounced deceased. Harris County Sheriff's Office Homicide and Crime Scene Units responded to the scene and conducted the investigation. The homeowner advised investigators that the

male intruder threatened to kill him and advanced toward him while reaching into his pocket. The homeowner stated he believed the male had a weapon and was in fear for his life. The homeowner said he shot the male intruder as he advanced toward him."

After further investigation, evidence was uncovered and statements were obtained which indicated that John Rodgers, 61, did not act in self-defense and was not in fear for his life at the time he shot Eric Scheele, 60, to death. The HCSO Homicide Unit charged John Rodgers with the murder of Eric Scheele. He was arrested on June 10, 2021 by the HCSO Warrants Unit.

# Highlands home invasion turns deadly

HIGHLANDS – On July 2, 2021, at approximately 10:50 AM, several armed males forced entry to the residence located at 2403 Orange Blossom Ln, according to HCSO spokesperson Sergeant Dennis Wolfford.

The armed males, who were masked and wearing body armor, began demanding money from a female and her three children. The suspects began ransacking the home as the family was held at gunpoint.

During the armed home invasion, the husband, Martin Alamillo, returned home. He was shot multiple times as he entered the front door of the residence. Harris County Sheriff's Office patrol deputies and EMS responded to the scene. The male was pronounced deceased at the scene.

The suspects fled the scene in a blue Chevrolet truck. Harris County Precinct 3 Deputy Constables spotted the vehicle and a pursuit was initiated. The suspect's abandoned the vehicle in the 1900 block of Gulf Pump Rd. and fled on foot. Several law enforcement agencies

established a perimeter and one of the suspects was caught. The suspect, Ruben Garcia, confessed his role in the robbery and murder to Harris County Sheriff's Office Homicide investigators. Ruben Garcia will be charged with Capital Murder and booked into the Harris County Jail.

The investigation into the other suspects involved continues. Anyone with information about this incident is asked to call HCSO Homicide at 713-274-9100 or Crime Stoppers.



### Productive Pain

Growth and pain go hand in hand. We simply cannot have one without the other and trying to protect anyone from all pain is counterproductive. Far better. for instance, if parents allow children to experience pain and challenges a little at a time while holding their hands, helping them learn how to deal with life's hurdles. It enables kids to mature and prepare  $% \left\{ 1,2,...,n\right\}$ to face a life in which things won't always go their way.

This truth was illustrated in one recent study that compared two groups of children. In it, the children who had to face challenges and conquer them were far happier and more successful over all than those children who were "privileged" to have had most or all challenges removed. Man is designed to face life and conquer it, not hide from reality and only exist. We've seen in today's culture how overprotective parents have created a large group of adults who only exist, drifting through their problem not just for the individual, but for society as well.

With all of this in mind, let's look at the current state of the

church. Many churches today are feeding this very weakness, this unwillingness to face pain or even discomfort. They have determined that the people they want to attract "can't take" the painful challenges presented by the strong points of the Gospel, so they set aside large portions of the Word to make those people feel more at ease This tactic may get warm bodies into the sanctuary, but it doesn't help the members they gain grow spiritually.

Maybe it's time to pull out the old WWJD  $bracelets\ because\ Jesus$ did things differently. Jesus was in the Synagogue, teaching, on a regular basis; He laid the truth out in a strong way that religious people hated and sincere people hungered for. Then He went out into the highways, sat on the mountainsides, and preached from boats, unapologetically giving His listeners what they really needed, again...whether they liked it or not. Yes, He presented truth to them in a way they could derstand but He didn't hold back and He expected them to take the truth and grow.

It hurts to see how much of the modern church has turned aside

from presenting the Gospel as clearly and completely as Jesus would have. Like those overprotective parents, all too many ministers have watered down the message and let people merely exist as spiritual babies far too long. ties, and other strategies as part of Texas' comprehensive border security

SOCIAL MEDIA CENSORSHIP: Legislation safeguarding the freedom of speech by protecting social-media users from being censored by social-media companies based on the user's expressed viewpoints, including by providing a legal remedy for those wrongfully excluded from a platform

ARTICLE X FUND-ING: Legislation providing appropriations to the Legislature and legislative agencies in Article X of the General Appropriations

FAMILY VIOLENCE PREVENTION: Legislation similar to Senate Bill 1109 from the 87th Legislature, Regular Session, requiring schools to provide appropriate education to middle- and high-school students about dating violence, domestic violence,

and child abuse, but that recognizes the right of parents to opt their children out of the instruction.

YOUTH SPORTS: Legislation identical to Senate Bill 29 as passed by the Texas Senate in the 87th Legislature, Regular Session, disallowing a student from competing in University Interscholastic League athletic competitions designated for the sex opposite to the student's sex at birth.

THIRTEENTH

CHECK: Legislation similar to House Bill 3507 from the 87th Legislature, Regular Session, relating to a "thirteenth check" or onetime supplemental payment of benefits under the Teacher Retirement System of Texas.

CRITICAL BACE THEORY: Legislation similar to House Bill 3979 concerning critical race theory as originally passed by the Texas Senate in the 87th Legislature, Regular Ses-

property-tax relief; enhanced protection for the safety of children in Texas' foster-care system by attracting and retaining private providers for the system; and


