# Crosby ISD will elect 7 new trustees in November message -- Grateful

#### Filing Period begins July 23

CROSBY - The filing period begins soon for members of the public who wish to run for a seat on the Crosby Independent School District Board of Trustees.

All seven Trustee positions will be on the November ballot as part of the 2020 Census Redistricting process. Positions 1 through 7, including the At-Large Position 6, will be up for election this fall. Elections are conducted biennially in November. However, the Board approved all seven seats on the ballot this year due to the redrawing of singlemember districts. The Redistricting process was completed to accommodate population changes between the 2010 Census

and the 2020 Census. The Candidate Filing Period begins July 23 and runs through August 22nd at 5pm. Applications are accepted at the Crosby ISD Operations Center, 14670 FM 2100, Crosby, TX, 77532. Applications must be notarized. Our staff members can serve as a notary if needed.

There are a number of eligibility and application requirements to be a Crosby ISD Board of Trustee member. Among them: you must be a resident and registered voter in the singlemember district from which you are running. The at-large position is available for any resident who is a registered voter residing within the boundaries of Crosby ISD.

You can see the full list of eligibility requirements on Crosby ISD's 2022 Board Elections web page at www.crosbvisd.org/ boardelections. This site features a map with an address search to locate your single-member district; application documents; and deadlines for the election process. ### Goose Creek CISD Board Cheer is Life for GCCID of Trustees named Region Cheerleaders 4 Board of the Year.

HOUSTON (July 5, 2022)—The Goose Creek CISD Board of Trustees has been named the Region 4 School Board of the Year for 2021–2022 as part of the annual Texas Association of School Administrators (TASA) School Board Awards

The Goose Creek CISD Board of Trustees was recognized for its dedicated support to students and educators. The Board recognizes the importance of creating a culture of mutual respect and trust among all members of the education community. Accordingly, the district's educational philosophy focuses on providing each student access to highquality instruction, supports, facilities, and other educational resources. To support that philosophy, the board has approved a number of policies, including a 2019 bond that provided more than \$49.7 million for technology improvements as well as the expansion of the district's pre-k programs.

The board also has launched wellness initiatives for both students and staff members. Through Be Well Baytown, an initiative of the University of Texas MD Anderson Cancer Center, Goose Creek has implemented the CATCH curriculum, opened walking trails at four elementary school campuses, and added shade structures at five campuses to promote sun safety. To support employee wellness, Goose Creek has partnered with Next Level Urgent Care to provide full-time staff members with access to health and wellness resources, including medical care. The district also offers an employee fitness center.

'Congratulations to the Goose Creek CISD Board of Trustees for being selected as the School Board of the Year for Region 4, the Greater Houston Area! This is a historical event and the first for Goose Creek," said Dr. Randal O'Brien, superintendent, Goose Creek CISD. "I would like to thank our Board of Trustees for providing administration with a clear and concise vision of providing excellence in all that we do and a heart that challenges us to continuously improve what we accomplish each and every day for the sake of our students, faculty and the community that we love and serve."

Goose Creek also has seen continued gains in student performance, despite COVID-19. Graduates in 2021 earned more than \$16 million in scholarships, and 45 students earned associate's degrees in 2021–2022. The district also is home to nationally recognized college

and career readiness programs, with its STEM Academy, Health Science Academy, and Global Business Academy receiving Model status from the National Career Academy Coalition.

Goose Creek CISD serves nearly 24,000 students in the communities of Baytown and Highlands. The district includes six high schools, six junior high schools, and 16 elementary schools. Two new elementary schools, an Early Learning Academy, and the GCCISD Robotics Center are slated to open for the 2022-2023 school year. Goose Creek CISD is the largest employer within the district boundaries with more than 4,000 staff members.

The junior high program focused on crowd leading and skill fundamentals, with exclusive material just for their grade level. Attendees had the opportunity to perfect their stunts, pyramids and jumps; receive private coaching, leadership training and more, but the highlight of the camp was "Friday Night Lights." Cheerleaders and their coaches dressed up in camp-themed spirit gear, as they participated in team building activities designed to increase motivation, promote cooperation and build memories. The camp concluded with an awards ceremony. The Lee High School team went home with two superior ribbons, two Pin It Forward recipients and one All-American. Sterling received second for cheer, two overall Game Day, five All-Americans and one Pin It Forward. Highlands, Horace Mann, and Baytown Junior won first, second, and third place for overall junior high.

UCA was founded by Jeff Web in 1974 to provide the best educational training for cheerleaders with the goal of incorporating high-level skills with traditional crowd leading. Today, it stands as the largest cheerleading camp company in the


continues to be an important part of the fabric of Goose Creek CISD.

#### Deadline to Apply for the Homeowner Assistance and Reimbursement Program is August 31, 2022

AUSTIN — Today the Texas General Land Office (GLO) announced the application for the Homeowner Assistance and Reimbursement Program (HARP) will close at 5 p.m. on Aug. 31, 2022.

The GLO allocated \$137.8 million of Community Development Block Grant - Disaster Recovery (CDBG-DR) funds from the Department of Housing and Urban Development (HUD) for repair or reconstruction of owner-occupied singlefamily homes and reimbursement up to \$50,000 for certain out-ofpocket expenses incurred for reconstruction, rehabilitation, or mitigation. Repayment of SBA loans is also eligible for reimbursement.

**HARP Regions: South** Texas and the Rio **Grande Valley** (\$66,196,000): Cameron, Jim Wells, Hidalgo, Willacy

#### **Tropical Storm** Imelda

(\$71,604,000): Chambers, Harris, Liberty, Jefferson, Montgomery, Orange, San Jacinto

A single application can be submitted for reimbursement and repair assistance. HARP is a firstcome, first-served basis and all homeowners are encouraged to apply immediately. HARP is only available for a main home (primary residence).

The HARP regional offices will remain open, and processing of applications will continue indefinitely until program funds are fully expended. New applicants can also call the toll-free intake center line at 1-866-317-1998. Applications will be considered for award on a first-come, first-served basis, according to the priorities outlined in the Regional Housing Guidelines. Submitting a complete application does not guarantee eligibility nor funding availability.

Potential applicants should review the Homeowner <u>Assistance and</u> Reimbursement Programs <u>Checklist</u> to have all applicable documents ready prior to applying. Interested homeowners

should visit recovery.texas.gov/ harp to apply online or download a printable version of the application.

# **Mont Belvieu Murder Suspect** dead in Harlingen car accident

(Mont Belvieu, Texas) Mont Belvieu Police Chief Jimmy Ellison has announced that Osvaldo Rodriguez, the suspect wanted in connection to last Thursday's (June 23rd) murder of his estranged wife, Magdalena "Maggie" Rodriguez in Mont Belvieu, has been confirmed to be deceased in Harlingen, TX. Chief Ellison has notified both families.


Thursday evening at 6 p.m. in Harlingen TX, a fatal auto-pedestrian crash occurred on the North 77 Expressway,

in which a male pedestrian with no identification on him, was struck and killed by a passing van shortly afvehicle parked on the shoulder. Harlingen PD had been working to identify the unknown

deceased subject but had been unsuccessful until a fingerprint comparison determined him to possibly be Osvaldo Rodriguez, whose Murder warrant had been uploaded by MBPD into the Texas and National Crime Information Cen-

Harlingen PD contacted Mont Belvieu PD late Monday and through cooperative efforts, both agencies were able to positively identify the Harlingen fatality as MBPD fugitive Osvaldo Rodriguez.

As previously reter he stepped out of a leased last week, with-

in a few hours of the homicide that occurred at 6:40 a.m. Thursday

morning, MBPD had determined Mr. Rodriguez to be in Beaumont. MBPD then actively worked with Beaumont PD in searching for him in the area near College Street and I-10 where he was last seen. While searching

that area, investigators were able to locate and recover the vehicle used by Rodriguez, but were unable to ascertain any further information as to his whereabouts or destination. MBPD's investigation remained active at that point, culminating with Monday evenings information from Harlingen PD.

Mont Belvieu PD will continue to work certain aspects of the homicide investigation and will assist Harlingen PD as needed pertaining to their auto-pedestrian crash investigation. ### What Does Shortness of Breath Feel Like & When Is It Serious?

Breathing is an automatic process, meaning it's carried out without any conscious effort on

So, when breathing becomes a conscious effort — such that you're short of breath and have to remind yourself to take deep breaths — it can be frightening, especially if you've never experienced it before.

"Shortness of breath is a symptom that can be associated with many conditions, primarily heart and lung conditions. Both of these are incredibly important organs, so it's never a good idea to ignore shortness of breath," says Dr. Skantha Manjunath, a pulmonologist at Houston Methodist Lung Associates in Baytown.

The many causes of shortness of breath include:

#### **Asthma**

Chronic obstructive pulmonary disease (COPD)

Pulmonary hypertension

#### **Pulmonary fibrosis**

Respiratory tract infection, including pneumonia or bronchitis

Heart conditions, such as cardiomyopathy, heart attack and heart failure

Obesity Being out of shape (muscle deconditioning) Anxiety or panic at-

### Where do you feel

shortness of breath? Shortness of breath is felt in your chest and can manifest as:

Difficulty catching

your breath Feeling a need to breathe more quickly or

Not feeling able to take a full, deep breath

Feeling huffy and

"You may first notice shortness of breath during physical activity." says Dr. Manjunath. "And shortness of breath can progress over time, to the point where you experience it even while at rest."

But not all shortness of breath develops slowly over time. Sometimes,

shortness of breath hits suddenly, and maybe even severely.

When shortness of breath is acute, it's typically accompanied by other symptoms, such as: Fever and cough

(pneumonia) Itching, swelling or a

rash (allergic reaction) Wheezing (asthma)

Pain in the chest, blurry vision and lightheadedness (heart attack)

Chest pain and leg swelling, especially after long travel (pulmonary embolism)

#### When is shortness of breath serious?

Importantly, if shortness of breath is moderate to severe and occurs suddenly — and especial-

cutting ceremony

ly if it's accompanied by chest pain, lightheadedness and changes to the color of your skin — it's become a medical emergency that warrants a call to 911.

"This can be a sign of a heart attack or pulmonary embolism, which are both life-threatening emergencies," says Dr. Manjunath.

Then there's the milder shortness of breath experienced on occasion with physical activity. While this isn't a medical emergency, it's not something to ignore either.

#### What does shortness of breath mean?

Shortness of breath occurs when you're not getting enough oxygen, leaving you to feel like you need to breathe harder, quicker and/or deeper. And, if you feel like you're not getting enough oxygen, your organs aren't either — which can have serious shortterm and long-term consequences to your health.

"Shortness of breath can be caused by a variety of conditions, ranging from asthma and COPD to heart failure. Your doctor can run the tests needed to help make a diagnosis, as well as offer lifestyle recommendations or prescribe medications that can help treat the underlying cause of your shortness of breath," explains Dr. Manjunath.

For instance, if you are diagnosed with asthma, your doctor may prescribe an inhaler and recommend you quit smoking (if you smoke) and avoid other lung irritants.

If shortness of breath continues to progress despite lifestyle modifications and treatment, your doctor may refer you to a pulmonologist or cardiologist, depending on the source of your shortness of breath.

### LWV comments on Supreme Court abortion ruling

Austin, TX – On June 24, 2022, all abortion clinics in Texas stopped providing abortion services. This will have devastating consequences for Texas women.

The United States Supreme Court issued its opinion in Dobbs v. Jackson Women's Health Organization on June 24, 2022. In this opinion, the Court overturned almost 50 years of precedent going back to its seminal decision in Roe v. Wade, the 1973 decision that found that women have a constitutional right to abortion. As a result of the Dobbs opinion, there is no longer a recognized federal constitutional right to an abortion. Women's rights will be determined by their state legislatures.

During the last Texas legislative session, a socalled "trigger law" was enacted which bans abortions in Texas if the U.S. Supreme Court overturns Roe v. Wade. This ban becomes effective 30 days after the issuance of a Supreme Court decision overruling Roe. There are no exceptions for pregnancies that result from rape or incest. There is an exception if the physician determines that the woman has a life-threatening physical condition that places her at risk of death or substantial impairment of a major bodily

However, Texas Attorney General Ken Paxton issued an advisory that prosecutors could immediately pursue prosecutions based upon Texas law that pre-dated the 1973 Roe decision. As a result of questions regarding when an abortion ban would become effective, abortion funds and providers have paused their operations.

"The League of Women Voters of Texas strongly supports women's access to comprehensive reproductive health services, including safe, legal abortions. The Dobbs opinion is an affront to the dignity of women and their ability to make their own decisions regarding their bodies and their futures. This decision puts the health of millions of women in danger, and it creates a hardship on women who do not have the financial means to travel out of Texas for abortion services," explained Joyce LeBombard, president of the League of Women Voters of Texas.

The League of Women Voters has been advocating for reproductive justice for forty years. The League of Women Voters of the United States provided this statement on June 24, 2022.

The Texas League will continue to fight for both state and federal legislation that protects women's liberties and their right of self-determination as to their reproductive choices, including abortion access.



### Abortion now Officially Illegal in Texas

The U.S. Supreme Court ruling overturning Roe vs. Wade effectively ends all legal abortions in Texas within the next 30 days, many news media outlets reported.

"Planned Parenthood and Whole Woman's Health, with clinics across Texas, stopped performing abortions following Friday's decision, due to uncertainty about how the ruling will affect the state's trigger law and a long-standing ban on abortion that predates Roe v. Wade, officials with those organizations said," according to the Austin American-Statesman.

"Texas is a pro-life state, and we have taken significant action to protect the sanctity of life," Gov. Greg Abbott said in an issued statement.

Beto O'Rourke, Abbott's Democratic opponent in the November gubernatorial election, said on Twitter, "I will always fight for a woman's freedom to make her own decisions about her own body, health care, and fu-

#### STATE SENATOR SUES DPS **OVER UVALDE RECORDS**

State Sen. Roland Gutierrez, who represents Uvalde, has sued the Texas Department of Public Safety over records relating to the Uvalde school shooting that have been withheld.

"In the wake of the senseless tragedy, the people of Uvalde and Texas have demanded answers from their government. To date, they have been met with lies, misstatements, and shifts of blame," Gutierrez said in a lawsuit filed Wednesday, according to the Texas Tri-

Both state and local Uvalde officials are contesting releasing the records that could shed light on the botched emergency response to the shooting, which killed 19 children and two teachers. Law enforcement responding to the shooting waited more than an hour before breaking into the



classroom to kill the shooter.Meanwhile,

Gov. Greg Abbott said his office has been transparent in providing information since the May 24 massacre, in a statement released by his press secretary: "The governor and his office will continue making all available information public, including the full results of the ongoing investigation by the Texas Rangers and the FBI. The governor wants all facts of this tragedy to be made public as quickly as possible and will do his part to

The risk of wildfire across a large swath of Texas continues as the state enters summer after enduring a hot, dry spring.

The Texas A&M Forest Service reported that last week marked the third week in a row with high-pressure weather systems dominating

the state. Above-normal temperatures and below normal rainfall are again forecast throughout Texas. As a result, the forest service reported responding to seven wildfires that burned more than 1,000 acres as of late last week. All but one had  $been\ contained -- the\ Demp$ sey Fire in Palo Pinto County, which has burned more than 1,000 acres.

A total of 160 Texas counties have enacted burn bans

#### APPLICATIONS TO BECOME A 'BIRD CITY' NOW ACCEPTED

It's time for cities to go to the birds.

Audubon Texas and the Texas Parks and Wildlife Department are accepting applications from communities that would like to receive Bird City Texas certification. The program, in its fourth year, recognizes the contributions that communities make to improve nature in and around where people

live, work and play. "All communities, big and small, are eligible to participate," says Richard Heilbrun with TPWD. "Bird City Texas is a great way to demonstrate that a community values nature, that they're willing to improve that nature, and that residents are encouraged to get outside and experience nature."

Certification is based on work in three categories: education and engagement, habitat management and improvement and removal of threats to birds. Community residents are encouraged to be part of the process, Heilbrun said.

Applications for Bird City certification will be accepted through Dec. 2, but applications must be started by Nov. 1. More information can be found here: https:// tpwd.texas.gov/wildlife/birding/bird-city-texas.

#### **COVID-19 CASES UP, DEATHS DOWN**

The number of new COV-ID-19 cases reported by the Coronavirus Resource Center at Johns Hopkins University rose once again in Texas the past week, with 61,682 reported — up 28% from the previous week, though deaths dropped sharply to 66. The number of lab-confirmed COVID-19 cases in Texas hospitals rose to 2,055, up 17.6% from the previous week.
