GONZALO ECHEVERRIA McCord Development

Members of the North Channel Chamber of Commerce recently heard from McCord's Director of Design and Planning, Architect Gonzalo Echeverria. He spoke about the history of the project, and how the Master Plan is evolving as the development gets built-out.

# No More Late Fees at Harris County Libraries!

HARRIS COUNTY – Commissioners Court unanimously approved a proposal by Harris County Public Library (HCPL) to end library fines on books and DVDs that are returned late. With the Commissioners' backing, HCPL joins a growing number of public library systems across the country that have eliminated late fees over the last several years.

Harris County Public Library has waived late fees since March 2020 when the Covid-19 pandemic forced the closure of all its branch locations. Harris County Commissioners on Tuesday made the policy permanent. Under the new policy, patrons will still be charged for lost or damaged items, but effective at once, patrons will not be charged for returning items past their due dates, and overdue fines that are already on library users' accounts will be forgiven, though it may take

some time for these changes to appear on library accounts.

For HCPL, like many other libraries, the decision boils down to matters of economics—both for the library and the communities it serves. Chief among them is the fact that late fees hit low-income households harder than others. Late fees—even relatively small amounts—can and do effectively block eco-

nomically disadvantaged people from using the library.

"The elimination of late fees makes HCPL the open, free public resource it was always meant to be," said Edward Melton, HC-PL's Executive Director. "We want to remove barriers and ensure that our collections and services are

# FM2100 set to Reopen this week



Construction work on the segment between Highlands and Crosby continues, and is scheduled for completion by the 4th quarter of 2023. Like the FM2100 segment, it will be a 5 lane highway, with a median.

TxDOT has indicated that the 8-mile segment of FM2100 being rebuilt, from South Diamondhead in Crosby to FM1960 in Huffman, is set to reopen this week.

The widening and rebuilding of FM2100 started construction in 2019, and was expected to be complete by early 2021, but delays in this section

and the segment south to Highlands extended the completion date. During construction there have been numerous serious accidents, as lanes were switched for construction.

The completed roadway, from I-10 to Huffman, will be four lanes divided by a median, and should help alleviate delays and congestion, TxDOT said.

# 5 workers win \$28m lawsuit vs ExxonMobil

ExxonMobil to pay over \$28 million to 5 workers injured in 2019 plant explosion

BAYTOWN, Texas -According to a news release from a Houston law firm, they were able to secure over \$28 million on behalf of five plant workers who were injured in an explosion at ExxonMobil Baytown Olefins Plant on July 31, 2019.

The explosion was caused after a line ruptured due to build up of an industrial byproduct, popcorn polymer. The impact from the explosion destroyed the tower and created a fireball approximately 900 feet tall.

The law firm of Abraham, Watkins, Nichols, Agosto, Aziz & Stogner claim that ExxonMobil

had knowledge for decades that popcorn polymer was an extremely hazardous substance that could lead to a large plant explosion and that the company did nothing to implement safety practices to avoid such an event.

ExxonMobil was also accused by the firm that it withheld knowledge of those risks and never warned any of the plant workers who have filed lawsuits against the company for injuries suffered in the explosion, including the workers represented by the firm.

During the trial and three-and-a-half years of litigation, ExxonMobil denied all allegations. The company also disputed the injuries that each plant worker suffered in the explosion, according to the release.

After three weeks of tri-

al, the jury returned a verdict finding ExxonMobil 100% responsible for the explosion and awarded \$28,951,000 in damages to compensate the plant workers for their injuries.

Over the past 10 years, it was noted that OSHA has fined ExxonMobil's Baytown complex for eight safety violations, seven of which were classified as serious, the release reads.

Other injuries at the Baytown complex reported from lawsuits filed in Harris County against the company over the last decade range from Benzene exposure to electrocutions, as well as several others suffering multiple injuries during explosions and fire evacuations.


This newspaper asked ExxonMobil for a comment or statement on the lawsuit, but to date no response has been received.

## Do Breast Implants Affect Mammograms

Perhaps you've read or heard that breast implants complicate mammogram readings, prompting you to wonder whether yours make the screening guidelines inapplicable for you. Maybe you're even considering skipping your annual mammogram, questioning its worth.

But Dr. Ana Benveniste, breast radiologist at Houston Methodist Baytown Hospital, stresses that all women benefit from getting an annual mammogram — including those with breast implants.

"If we can find and treat breast cancer early, it's almost always curable," says Dr. Benveniste. "And the only way we can do that is if you come in for your annual screening mammogram. Having breast implants doesn't change that."

Do breast implants cause

breast cancer? The two most common types of breast implants used today, saline and silicone, aren't associated with an increased risk of breast cancer. This means that a woman doesn't need to be screened earlier or more frequently just because she has breast implants. There are very unusual cancers related to breast implants such as "Breast Implant-Associated Lymphoma" (BIA-ALCL) - it is a type of non-Hodgkin's lymphoma (cancer of the immune

system and it is not a breast cancer) and "Breast implantassociated squamous cell carcinoma" (BIA-SCC) - it is a very rare but potentially aggressive, epithelial-based tumor that appears to emanate from the breast implant capsule (it is not a breast cancer).

Primary risk factors for breast cancer include:

Increasing age Breast density

Mutations (changes) in cergenes, such as BRCA1 and BRCA2

Family history of breast

How often should you get a mammogram?

The breast cancer screening guidelines for women with an average lifetime risk of developing breast cancer with breast implants are the same as for women without them.

"It's still an annual screening mammogram — once a year — starting at age 40," says Dr. Benveniste. "This is the gold standard recommendation that all women benefit from, which the data has proven over and over."

If your risk of developing breast cancer is high, however, your doctor may recommend beginning annual mammograms earlier - as early as age 30. But having implants doesn't put you at high-

er risk.

Reasons a woman may be at higher risk for breast cancer include:

Genetic testing has revealed that you carry a gene mutation that increases your risk of breast cancer

Having a parent, sibling or child with a known breast cancer gene mutation

Undergoing radiation therapy to the chest under the age

Having Li-Fraumeni syndrome, Cowden syndrome or Bannayan-Riley-Ruvalcaba syndrome, all rare genetic disorders that increase the risk of certain cancers

Do breast implants affect mammograms?

In short, ves. Breast implants make it harder to see the entirety of vour breast tissue on a mammogram, potentially obscuring findings.

"On a normal mammogram, we evaluate the tissue all the way from the nipple through the pectoralis muscle to the chest wall," explains Dr. Benveniste. "However, when you have an implant, the posterior tissue of the breast is blocked from the mammographic field of view. Since we don't have a clear view all the way back to the chest wall, findings could be missed."

Both common types of implants, saline and silicone, affect mammogram readings in a similar fashion.

Not to worry, though. Mammography technologists know how to work around this, which is why it's important to let your breast-care team know if you have implants before or at your appointment.

How are mammograms done with breast implants?

In addition to taking the traditional full-field views of vour breasts — two images per breast — several more pictures are taken of women with implants. These extra images, called implant-displaced views, help the radiologist evaluate tissue that would otherwise be blocked by the implants.

"After the standard images are taken, the mammography technologist manually pushes the implant back while pulling the breast tissue forward — in front of the implant - and compressing it," says Dr. Benveniste. "Two more images are then taken. This process helps penetrate as much of the breast tissue as possible, providing images in which the implants are no longer obscuring the tissue."

This is repeated for the other breast — leading to four images per breast, eight images total.

While more images are needed because of breast implants, Dr. Benveniste notes that there isn't any exam instead of the mammogram recommended for women with implants.

Can a mammogram cause a breast implant to rupture?

A critical part of a mammogram is compression of the breast tissue, which may have you wondering whether your implants are at risk for rupturing during the process.

According to a recent review, breast implant rupture during a mammogram is extremely rare.

In short, worrying about an implant rupturing is no reason to skip your mammogram.

#### Let Voters decide whether to keep Daylight Savings Time... or Not

Sen. Paul Bettencourt & Rep. Mike Schofield Say Let Texans Vote on Daylight Saving Time! SJR 86 lets voters decide to eliminate time shift that occurs this weekend; Fall vote stops "spring forward"

Austin, TX – Senator Paul Bettencourt (R-Houston) filed SB 2329 & SJR 86 to let Texans vote on eliminating Daylight Saving Time. If the voters approve, this would group Texas with Arizona and Hawaii, the only two states that do not currently observe Daylight Saving Time in the United States.

"When you think of hot-button public policy issues, what usually comes to mind are things such as property tax relief and school finance and pension reform. However, the issue of Daylight Saving Time has roused passions on both sides of the debate for over 100 years," said Senator Bettencourt. "Texans like me want to be on one time, and the Federal government doesn't give us the option to vote to remain on standard time. SJR 86 gives Texans the opportunity to vote on the issue and settle the debate once and for all in the Lone Star State!" He added.

SB 2329 & SJR 86 would apply to all portions of Texas using Central Standard Time and Mountain Standard Time. If passed, the bill would require a vote on the November 7, 2023, General Election, where Texas voters would decide whether or not to abolish Daylight Saving Time. If approved by the voters, the change would take effect in 2024. Daylight Saving Time was first enacted in the United States during World War I but was repealed in 1919 over the Veto of President Woodrow Wilson. It was restarted during World War II, but it was repealed again three weeks after the end of the war during the Truman Administration. A patchwork quilt remained until Congress passed the Uniform Time Act in 1966, which allows States to remain on standard time if they wish.

"Texans are tired of having to change their clocks and lose an hour's sleep for no reason," said Rep. Mike Schofield (R-Katy, Cypress), the House author of the bill (HB 417 & HJR 22.) "People would like to get home from work and play with their kids without it being dark half the time. There's no reason not to fix this."

One major justification given for Daylight Saving Time is that it reduces energy consumption. However, studies on the issue have been mixed, with a 2008 Department of Energy study finding that an extended Daylight Saving Time "saved about 0.5 percent (1.3 billion kilowatt hours) in total electricity per day" over a fourweek extension. A University of California Santa Barbara study however found that when Indiana moved to a statewide system in 2006 it caused a 1% increase in residential electricity use. At the Federal level U.S. Senator Marco Rubio (R-Florida) reintroduced legislation to make Daylight Saving Time permanent and end the twice a year adjustment of clocks.

"Instead of fall back and spring forward, it would be a fall vote to stop a spring forward!" Concluded Senator Bettencourt.

EDITOR'S NOTE: The above Opinion piece would eliminate Daylight Savings Time in Texas, just as Arizona and Hawaii do not observe it. The rest of the country would still be on Daylight Savings Time. HOWEVER, Senator Marc Rubio of Florida has introduced a bill in the U.S. Congress that would permanently KEEP Daylight Savings Time all 12 months, in all states nationally. It is not known whether this bill will be acted upon favorably, or adopted.

## House Pushes Armed Officer at All School

Under legislation prioritized by House Speaker Dade Phelan, every Texas school would have an armed police officer, and aspiring teachers would receive extra support.

The Dallas Morning News reported the bill would also provide \$15,000 in annual funding for safety measures for each school in the state. Another bill would increase the annual allotment per student for safety measures from \$10 to \$100

Another House measure is aimed at improving teacher retention and recruitment, The Morning News reported. The measure, sponsored by state Rep. Harold Dutton, D-Houston, would create a new grant to help prospective teachers pursing special education or bilingual certification, and would increase funding for educator mentoring. Special education and bilingual teacher positions are especially hard to fill in Tex-

#### RISING CAR INSURANCE **RATES CAUSING STICKER**

Average statewide auto insurance rates are up nearly 24% over last year, according to a report by the Texas Standard. That is the highest increase in at least 20 years, according to the Texas Department of Insurance. That comes on top of increased costs for vehicles both new and used, and higher fuel

Michael Schnurman, a business columnist with The Morning News, was interviewed on the Standard and had this to say, in part:

"There are several elements that play into it. One...is the higher values of cars and used cars in particular - they really shot up during the pandemic," he said. "But the claims are also up a lot...When driving resumed, the number of accidents and the severity of accidents has really been a lot higher. If you look at fatalities, I think they were up 18%."

Schnurman suggested consumers shop around for auto insurance and look for discounts for bundling it with homeowners' insurance or



multiple vehicles on the same account.

#### **PUC RECOMMENDS HEFTY FINE AGAINST POWER** COMPANY

The Public Utility Commission has recommended that the Texas-New Mexico Power Company pay a \$1.74 million fine for inaccurate estimates of its customers' electric usage.

In a report released last week, The PUC said the power company failed to correct a violation of an order to install new meters that can be read remotely in a timely manner.

The commission said "TNMP's new meter rollout was significantly delayed," resulting in the utility "estimating thousands of meters for months on end."

The investigation found that TNMP was given threeyears' notice that the "communication backbone" of its metering system was going to be discontinued by its thirdparty provider but failed to produce a plan until halfway through that timeframe. It also failed to have a backup plan in case its vendor could not provide the 170,000 new meters on schedule, according to the PUC.

#### **TEXAS SENATE PASSES FIRST BILL OF SESSION**

The Texas Senate last week passed a bill that would close a loophole in state law that allowed gun sales to people between the ages of 16 and 18 who have been involuntarily hospitalized for mental illness. The Texas Tribune reported it was the first bill passed by the Senate this session.

The measure comes after an 18-year-old shooter in Uvalde with a history of mental health problems killed 19 students and two teachers at Robb Elementary last year.

#### **WOMEN SUE STATE OVER ABORTION BAN**

Five women are suing the state, saying its near-total abortion ban resulted in them being denied abortions despite complications in their pregnancies that put their lives and fetuses at risk. The Austin American-Statesman reported the Center for Reproductive Rights filed the suit, which asks the courts to clarify what qualifies as a "medical emergency" exception in the law.

"Politicians in Texas are prohibiting health care that they don't understand; they could do something but they're not, and it's killing us," Lauren Miller, one of the plaintiffs, said. "It shouldn't be controversial for an individual to make health care decisions for themselves in consultation with their doctor. But you can't get that in Texas anymore."

The Statesman reported that Miller was pregnant with twins when doctors told her one of the babies had a severe genetic condition and was not going to survive. which threatened her life and the life of the other baby. She ended up traveling to Colorado to have an abortion and is scheduled to give birth to the healthy remaining twin this month.

#### **DROUGHT MAP SPREADS IN**

PARTS OF STATE Drought conditions by the end of February covered 62% of the state, up nine percentage points from a month earlier, according to Dr. Mark Wentzel, hydrologist with the Texas Water Development Board. Drought-free areas include all of East Texas up to Dallas County to the west and Jefferson County to the south. The most severe drought conditions are in the far northern edge of the Panhandle, the counties surrounding San Antonio, and nearly all of South Texas.

"The latest seasonal drought outlook from the National Weather Service is optimistic for East and North Central Texas," Wentzel wrote. "Through the end of May, that part of the state is expected to remain droughtfree. Unfortunately, drought is expected to expand in the rest of the state."



#### "More Useful"

I spent last week trying to be useful.

I volunteered for a writers' conference in San Miguel de Allende, Mexico, where my husband, Peter, and I stay. I love writers' conferences. I love that people will travel from far away just to talk about writing, to meet other writers, to learn about writing, to listen to established writers, and to eat. It was a terrific week, although it was tiring because I ended up as the designated conference sheepdog.

Every event of this kind needs at least one sheepdog, and since I had fewer administrative and computer skills than other volunteers, I was happy to do it. Being a conference sheepdog is exactly like being a real sheepdog except, instead of sheep, there are lost writers wandering around and getting separated from the herd—and I didn't actually nip at their heels.

Instead, I did my best to help them get to their workshop or other event. I tried to keep them in a tight group, and when I found a lost writer, bleating in the lobby, I restored them to the herd.

"Are you always here?" the writers started asking me on the second or third day.

"Always," I told them.

I figured, in a strange hotel, in a strange country, trying to do things they had never done before, having one person they could count on at the entrance of the hotel every morning might make the whole thing a little less daunting.

And I had fun. I sat in on several talks and discussions with writers, and I had a lot of interesting conversations with a lot of folks. At the end of the week, I had blisters on my feet, and I was very tired, but the conference went well, and I was proud I'd had a small part

It got me thinking about how important volunteers are. I have to confess, I don't volunteer a lot. My parents volunteer for all sorts of things. They help homebound seniors (who I suspect are considerably younger than they are). They help with church projects and funerals and fundraisers. My parents are an active part of their community up north, and I know they make a big differ-

ence. I have a friend who has been busy painting a set for a theater production all week. "I was on my hands and knees all day painting!" she told me. I felt bad complaining about my blis-

I don't do many things like that. I'm thinking I should do more.

Because volunteers of all stripes make things possible that would not otherwise happen—and the things that happen because of volunteers are some of the nicest parts of being in a community.

Volunteers help arts organizations and libraries. They help older members of their community, people new to their community, old people within their community, and people outside their community and around the world. Volunteers put out fires, teach children to read, organize concerts and festivals and parades and potlucks. Volunteers invest more than money. They spend their time. They give their hearts. Volunteers make wherever they live a better

"Thank you for volunteering!" the writers said as they left the conference for the last time. I don't think I deserve a lot of thanks just for being a sheepdog. That's how I am, naturally.

And I gained a new appreciation for how important being a volunteer could be. The blisters on my paws have healed and I am already thinking of ways I could be more useful in the future.

available equitably," Melton continues, "A late fee should not keep someone from the information and resources that can literally change their lives for the better."

Other factors in the decision to do away with late fines include the fact late fees generate less revenue than it takes to collect and process them, that fines have proven to be an ineffective deterrent to late returns, and most importantly, that libraries that have stopped assessing late fees have seen significant growth in library use, circulation, library

card applications and returned the materials.

"We hope, and the experience of libraries that have gone fine-free bears this out, that this will bring people back to our libraries," said Linda Stevens, HCPL's Division Director for Programs, Partnerships and Outreach, "not only to check out books and DVDs, but for things like our early literacy story times, Family Place Learning Centers and all the other interactive, educational programs we offer."

# Goose Creek Travis Elem. Assistant Principal arrested on drug charges

BAYTOWN, Texas – An elementary school campus assistant principal was arrested and charged after dropping a bag of cocaine in an employee bathroom at a Goose Creek Consolidated Independent School District campus, according to court documents.

Jessica Trice Sanchez, 40, of Houston, has been charged with pos-

session of controlled substance in a drug-free zone.

A staff member found the cocaine and then alerted the school's principal. The campus po-

lice department began the investigation and learned Sanchez dropped cocaine in the bathroom. Police said she also had additional cocaine in her vehicle.

Sanchez was arrested. She is now out on \$5,000 bond.

Travis Elementary School released the following statement regarding the incident:

"As educators, we must adhere to high professional standards as an example for our students, fellow colleagues and our community. When a colleague fails to meet those standards, we must be honest and transparent about those failures. Yesterday, a staff member made an irresponsible decision to bring illegal drugs into our school; specifically, into an employee bathroom, for personal use, to which no student had access.

The drugs were found by a fellow staff member, who then alerted the principal. The principal contacted the GCCISD Police Department, who began a thorough investigation. Upon the conclusion of the investigation, the employee was arrested for possession of a controlled substance and the DA is moving forward with pressing charges. Goose

Creek CISD is committed maintaining an alcoholand drug-free environment and will not tolerate the use of alcohol and illegal drugs in the workplace or at any school-re-

lated or school-sanctioned activities, on or off school property. Employees who use or are under the influence of alcohol or illegal drugs as defined by the Texas Controlled Substances Act during working hours may dismissed and the employee's criminal record will be reported to the Division of Investigations for TEA.

We are cooperating fully with the criminal investigation and will move forward swiftly to end the staff member's employment with the district. We will not, under any circumstances, tolerate this type of behavior in our schools. Our campuses are a safe haven for students and we will not have students in unsafe environments. We apologize that this happened, and we will continue to do our best to provide a safe, positive environment for students to learn."





HOLLYWOOD — Vancouver-born Ryan Reynolds, now 46, is returning to Canada to build a 1.2-million-square-foot movie studio in Markham, Ontario, Canada, for a mere \$1.5 billion. Reynolds got more gold than Fort Knox from starring and producing "Deadpool" (2016), which cost \$58 million and made \$782.6 million, and "Deadpool 2" (2018), which cost \$110 million and made \$785.8 million. The upcoming "Deadpool 3" will cost \$200 million and costar Hugh Jackman and Leslie Uggams.

Lest we forget Tom Cruise, whose "Top Gun: Maverick" grossed upward of \$1.4 billion, making it the 12th top grossing

film of all time. "Maverick" falls behind No. 1 grosser "Avatar" (\$2.9 billion), No. 2 "Avengers: Endgame" (\$2.7 billion) and newcomer and No. 3 "Avatar: The Way Of Water" (\$2.2 billion).

Cruise began shooting "Mission: Im-

possible — Dead Reckoning Part One" and "Dead Recknoning Part Two" back in February 2020, but they were shut down due to COVID and restarted shooting March 24, 2022. 


Raquel Welch ("The Three Musketeers")


