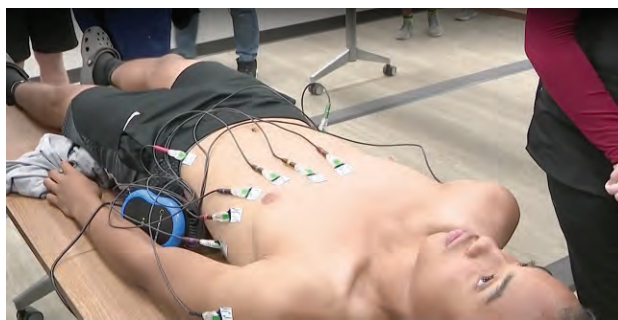

# Cody Foundation, KPRC help screen hundreds of kids for heart defects

Nearly 300 student athletes were given free heart screening test for heart defects by Cody Stephens 'Go big, or Go home' foundation and KPRC. The following story is from a TV report.

SPRING, Texas – Close to 300 student-athletes, some of the strongest, healthiest-looking, teenagers you could find anywhere, came with their parents this past Sunday to the Harris County ESD 11 Headquarters in Spring to potentially save their own lives.



Students undergo a simple ECG test that finds heart defects that might be fatal. Follow-up treatment will be a life-saver.

Students were invited to an absolutely free event that offers every teen an in-depth electrocardiogram heart test that can

identify hidden heart problems that just can't be found with a standard, high school sports exam. A test that goes light

years beyond any standard high school sports exam to spot hidden heart problems that every year kill unsuspecting, young athletes across the country.

At the event, every young athlete has his or her heart tested via electrocardiogram and was asked a series of questions about their heart history.

They were even taught how to do CPR.

The goal here is to uncover hidden heart defects you would never know

# Wife shoots ex-husband on Wallflower Street

EAST HARRIS COUNTY – An investigation is underway after Harris County Sheriff Ed Gonzalez said a woman's ex-husband was found dead outside a home in the 1300 block of Wallflower, near Baytown last Sunday morning April 2.

Harris County Sheriff

Ed Gonzalez said a couple, who was previously married, were involved in an argument when the woman grabbed a gun and shot her ex-husband.

The man, who appeared to be in his 30s or 40s, stepped outside, where he later collapsed and died, Gonzalez said.

The ex-wife then ran toward a neighbor's home, where she was eventually

### Retired officer confronts burglar in Highlands, resulting in shooting

HIGHLANDS – According to officials, an ex-Baytown police officer was involved in a shooting with a suspected burglar after chasing and then hitting his vehicle.

Harris County Sheriff Ed Gonzalez said on his Twitter account that Sheriff Deputies responded to an incident at East Wallisville Road and Thompson Road, near Highlands Junior High, at about 9:30 a.m. Tuesday March 28.

“It was reported a male hit another male with a vehicle and then gunfire may have been exchanged between the two,” Gonzalez Tweeted. “Both males

have been transported to hospitals; one of the two was taken by Life Flight.”

Gonzalez later Tweeted that, while preliminary, a retired police officer “located a male, he believed to be a burglary suspect. The retired officer struck the male with the vehicle,” Gonzalez Tweeted.

Officials said the officer began to follow the suspect after a home in Highlands Crossing was burglarized. A video shown on KRTRK-13 shows a suspect kicking in a door and entering through the backdoor. The homeowner was not in the house at the time. The burglar does not take any-

thing and leaves soon after an alarm goes off.

Other surveillance footage captured the suspect walking in the neighborhood after the break-in. The retired officer, who lives on the same street, saw the suspect and reportedly followed him in his vehicle. Shortly after that, the two had a confrontation, which led to a shootout.

Gonzalez added that the former police officer and the suspected burglar were said to be in fair condition.

“An investigation is underway,” Gonzalez said.

### 3 Struck, killed standing on I-10

HARRIS COUNTY – Three men are dead after they were struck by a suspected drunk driver in east Harris County early Friday March 31, deputies with the Harris County Sheriff’s Office said.

It happened shortly after midnight on I-10 East near Magnolia.

Deputies said the group was standing outside of their vehicle on the shoulder of the freeway, for reasons unknown, when a driver, identified as Jonathan Lazo, Jr. veered to the side of the road and struck all three men,

killing them.

Lazo was believed to be intoxicated at the time of the crash, according to deputies.

Deputies do not know the identities of the victims, but it is believed they’re all in their mid-20s.

“I just ask the community to pull together. We’ve got at least two families out here that are going to

be changed forever,” said Cpl. Anthony McConnell with HCSO. “And another thing I want the community to do is to stop drinking and driving. It’s a real simple and easy incident to avoid.”

Deputies arrested Lazo, who is now facing three counts of intoxication manslaughter.

## Lee College Debate Team Brings Home Four Championships

The Mendoza Debate Society at Lee College struck gold in The Gem State by winning four IPDA National Championships at the 2023 IPDA National Championship Tournament & Convention hosted by Boise State University on March 23-26, 2023. Lee College finished as both the 2022-2023 IPDA Season Long Community College Champions and the 2023 IPDA National Championship Tournament Community College Champions. Lee College was also named the 2023 IPDA National Championship Tournament Team Debate Community College Champions. Team co-captain Priscilla Guerra, IMPACT Early College High School student, was recognized as the 2023 IPDA National Championship Tournament Junior Varsity Division Champion.

At the 2023 IPDA National Championship Tournament, Lee College students brought home major awards as individuals as well. Jerry McCauley was a Professional

Division Semi-Finalist and was the 5th Ranked Professional Debate Speaker at the tournament. Team Co-Captain Diego Moreno was a Junior Varsity Division Double Octofinalist, while novice debaters Emma Jaramillo, Elias Perry and Carlos Reyes were all Novice Double Octofinalist. Moreno, Jaramillo, Perry and Reyes are all IMPACT ECHS students.

"When some of my opponents and judges from different universities were coming up to me to congratulate me, they were surprised to find out

that I was a high school student," said Guerra. "But anyone who adopted my mindset could have done what I did with the right training and motivation, probably even better than me. The goal was never to win a national championship, it was always for my friends and for the team."

Guerra, along with Co-Captain Rebecca Currie were the cornerstone of Lee College's TIPDA program and were instrumental in winning that national title.

For the season, the Mendoza Debate Society at Lee College finished as the 8th team in the nation in the 2022/2023 IPDA Founders' Cup overall standings, in 6th Place in the 2022/2023 IPDA Novice Squad standings, and in 6th Place in the 2022/2023 IPDA Junior Varsity standings. Individually, Reyes was the 3rd ranked 2022/2023 IPDA Novice Debater in the nation. Team Co-Captains Currie and Guerra finished in 11th Place and 13th Place respectively in the Junior Varsity Division.

Lee College's tradition of debate excellence was in full display in Boise, ID, just as it was in their 2015 showing in Boise; this year's team, despite being the youngest team in the nation, pulled off an impressive 7th Place overall finish against a field of dozens of nationally lauded programs.

Emma Jaramillo, Vanessa Jones, Co-Captain Diego Moreno, Jerry McCauley, Nathan Mustapha, Elias Perry, Dax Ramgoolam, and Carlos Reyes. They were accompanied by judges Riyanna Kennedy, Adam Naiser, and Kimberly Truong. Lee College Debate alumni Cody Bijou (University of Arkansas at Monticello), Reagan Bijou (University of Arkansas at Monticello), Linley Brown (University of Texas), and Lacey Gulley (Sam Houston State University) were also in attendance, along with Lee College Debate Assistant Coach Rigoberto Ruiz and Lee College administrator Dr. Marissa Moreno.

Lee College Debate will return to competition in April as an invitee in the prestigious James Madison Cup in Harrisonburg, VA where they will compete head-to-head against a select field of 18 top colleges and universities from across the nation including Cornell University, the University of Texas, George Washington University and Liberty University.

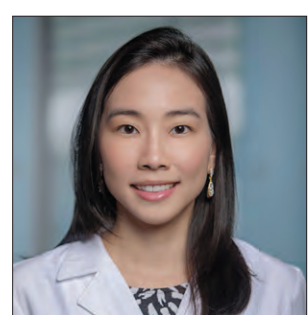

Inflation is up, but Homestead ISD Tax Bills are Not! Over 3.5 Million should see savings this Fall

Senator Bettencourt calls on Cities and Counties to adopt the No-New-Revenue-Rate this Fall Taxpayers should visit the State's New Tax Portal to get their Estimated Property Tax Bill

Austin, TX – Senator Paul Bettencourt (R-Houston) says that while the current National inflation rate is 8.6%, millions of under-65 Texas Homesteads should see their Independent School District (ISD) tax bills cut this Fall.

In May of last year, Texas' Voters overwhelmingly approved Propositions 1 and 2, which provided direct tax cuts to homeowners with homestead tax bills in 2022 and 2023. 2.1 Million over-65 or disabled homeowners will receive the benefits of the state's compressed property tax rate for school maintenance and operations (M&O) in 2023. Proposition 2 increased the statewide school homestead exemption from \$25,000 to \$40,000, meaning that over 3.5 million under-65 homestead homeowners will receive this tax cut this year. My Senate office calculations indicate an actual cut of \$44 on average for an average \$301,000 taxable homestead in Texas despite massive appraised value increases across the state. An office survey of the top 25 ISDs in the state indicates a range of cuts from \$107 to \$8. These calculated cuts comes before Cities and Counties set their tax rates in the Fall, which could save the average taxpayer hundreds of more dollars on their tax bills.

"The Cavalry is coming over the Hill for Texas Homesteads in the Fall, just like in an old John Wayne movie!" said Senator Paul Bettencourt. "Because of the passage of Prop 1 and 2 in May, 3.5 Million homesteads will on average pay less on their school tax bills this year than they did last year. Over-65 homeowners are frozen this year, but will get an actual property tax cut in 2023, too." He added.

Property Appraisals are rising amidst a booming Texas economy, but taxpayers can be assured that property tax rates are on the way down to offset these increases. This is attributed to the significant reforms contained in SB 2 and HB 3 that the legislature passed in 2019, and the additional property tax legislation that was passed in 2021. In fact there are 16 cents of property tax relief, overall a \$482 savings compared to last year's tax rate.

"Lawmakers have given property owners valuable protections against rising tax bills in this red hot real estate market, but there is no substitute for vigilance. Taxpayers must be prepared to weigh in with their local taxing jurisdictions if they believe tax rates are too high," stated Dale Craymer, President of Texas Taxpayers and Research Association. Note: TTARA supplied county and city penny rate reduction estimates.

The no-new-revenue-rate is the rate that provides the same amount of money to a taxing entity this year as last year. As Texans are having to be extra careful with their dollars due to very high inflation, government entities should be doing the same thing or go to the voters for adoption. "I am calling on all Cities and Counties to adopt the no-new-revenue-rate, it will save the taxpayers' money!" concluded Senator Bettencourt.

"Burro in Pants"

I saw the burro wearing pants and carrying a basket filled with paper flowers. "Oh, my gosh!" I said. "That poor burro."

There are several burros with this job in this Mexican town and, as burro employment goes, it's a pretty easy gig. The burro wears a rustic basket filled with bright paper flowers and is led by a man in a similarly rustic costume, and they follow wedding processions, providing photo opportunities for the guests. The burro is photographed dozens of times and spends the afternoon in the park, doing her best to look picturesque.

On weekdays, when weddings are less common, the burro and her handler park themselves on a narrow bit of cobblestone street with a beautiful view of the old church in the background. Tourists get their photos taken with the burro for a few pesos. I saw no harm in it until the day the burro showed up in pants.

"Oh, my gosh!" And I felt a sense of indignation rising on the burro's behalf.

I mean, it's one thing to carry around fake flowers all day. It is another thing entirely (according to me) to put the poor burro in trousers. To add insult to injury, the pants were not even on her back legs! She was wearing trousers on her front legs that made her look sort of like a little person with a donkey head.

"Outrageous!" I decided in furious defense of the burro's dignity. Making a burro dress up in a silly costume was somehow intolerable, as far as I was concerned. Her handler was making her look comical, a ridiculous punchline to lure more tourists in. She was a joke burro, and I decided—from my vantage point as the Tourist Who Knows Everything—this was unacceptable.

From that moment on, I made it my mission to restore the burro's dignity. On days when she showed up in pants, I shook my head disapprovingly and said, "No pants!" in Spanish. On days she showed up in her natural attire, I indicated my approval. "I am happy the burro has no pants!" I said—a phrase I am unlikely to need on many other occasions.

My mission was going well, I thought. The burro was showing up in pants far less often and everything was going well—until yesterday.

Yesterday, I actually stopped to talk to the burro's handler.

"I'm glad she is not wearing pants!" I reiterated as if, by now, he might not have gotten my point.

"I will show you," he said in English. And he gestured that I should come near.

The burro had large patches on the back of her legs where the flies had been eating her skin. He told me they hurt her, and he could not keep the insects away. He put poison on the spots, but it did not work well, and it cost 500 pesos for a small bottle. The pants kept the flies away and allowed her poor legs to heal. And I am an idiot.

"I'm so sorry," I said in Spanish. "I didn't understand. She should wear pants if she needs them!"

And I thought of all the assumptions I make every day, all the opinions I form with no basis but my own ridiculous preconceptions. This man took the time to show me the truth—about one little burro in pants—and I wondered how often I am just so, so wrong.

"Gracias," I told him. "De nada," he said. "It's nothing."

But of course, it was something. It was something very important.

House OKs \$302 Billion Budget

The Texas House approved a \$302 billion budget last week that included an amendment prohibiting the use of state money on private school tuition — a major setback to Gov. Greg Abbott's plan to establish a school voucher system. The Austin American-Statesman reported that more than 20 Republicans joined nearly all House Democrats to pass the amendment, while 11 lawmakers voted present.

The amendment is seen as a rebuke to Abbott, who has traveled the state pushing what he calls "school choice."

The amendment's sponsor, state Rep. Abel Herrero, D-Robstown, said his proposal to block using public money for private schools boiled down to "public money for public schools."

The House's budget now heads to the Senate, which has passed an education reform bill calling for \$8,000 in state funding a year for a student who attends a private school. Since that funding is not included in the House budget, the issue could lead to tense conference committee negotiations between the two chambers. Some lawmakers have speculated the conflict could lead to a special called legislative session after the regular term ends on Memorial Day.

Among the highlights of the House budget are record funding increases for public schools and highway construction, as well as raises for state employees.

CONTROVERSIAL ELECTRIC GRID PLAN PASSES SENATE

The Texas Senate has passed a controversial plan to build more natural gas-powered plants in the state, despite widespread opposition from critics who say the two bills could lead to billions in added costs to customers. The goal of the bills, according to its sponsors, is to avoid another massive power outage such as the one in the winter of 2021 that killed more than 200 people, the Texas Tribune reported.

Houston Chronicle columnist Chris Tomlinson reported that 22 out of 24 people who testified on Senate Bill 6 voiced opposition. The plants would sit idle at least 97% of the time.

Companies of Texas found common ground with the Sierra Club. Texas Competitive Power Advocates agreed with the South Texas Electric Cooperative. Energy giant NRG joined the consumer advocacy group Public Citizen in declaring SB 6 a lousy idea," Tomlinson wrote.

State Sen. Charles Schwertner, R-Georgetown, the lead sponsor of both bills, said the measures were "in memory of the hundreds of Texans that died and the millions of Texans that suffered."

COURT RULES DEGREES CAN BE REVOKED FOR MISCONDUCT

The Texas Supreme Court reversed previous lower-court rulings and ruled last week that Texas universities can revoke previously awarded degrees for academic misconduct, the Statesman reported. The University of Texas at Austin and Texas State University, in separate cases that were consolidated, argued they should be able to revoke doctorate degrees from students who committed academic misconduct to "protect their reputations and the value of degrees conferred upon their students."

Both cases involved students accused of fabricating data that was discovered after the degrees had been conferred. Both students sued their respective universities after their degrees were revoked.

"The only difference between expelling a current student for academic misconduct and revoking the degree of a former student for the exact same academic misconduct is one of timing," Justice Debra Lehrmann wrote.

TEXAS PRISONS

The indoor temperature inside at least 15 state-operated jails and prisons exceeded 100 degrees last summer, according to a report by The Dallas Morning News. The data indicates that both inmates and staff are exposed to dangerous levels of heat in the state's facilities that do not have air conditioning.

A lack of climate control has contributed to the deaths of nearly two dozen inmates between 1998 and 2012, according to the Texas Department of Criminal Justice, as well as the heat-related illnesses of dozens of prison guards.

The News reported that state standards say county jails and animal shelters should get no hotter than 85 degrees, but Texas prisons are not required to have air conditioning.

While previous attempts to fund air conditioning for the state's prisons have failed, the House budget passed last week sets aside more than a half-billion dollars for that purpose. In addition, two bills to install cooling systems in the prison system were approved in committee.

LAND OFFICE AWARDS \$6 MILLION FOR COASTAL COUNTIES

The Texas General Land Office has awarded \$6 million for projects across seven coastal counties with a combination of federal and state funding

The projects are intended in part to improve amenities for greater beach access in a number of locations, as well as developing early warning systems for coastal flooding

"As a Texan who grew up near the coast and lived in Galveston for more than a decade, preserving our state's precious shorelines and their communities is a top priority of mine," said Land Commissioner Dawn Buckingham.

TENTATIVE SETTLEMENT IN TEXAS CHURCH SHOOTING

The Justice Department last week announced a tentative \$144 million settlement with the families and victims of a 2017 mass shooting at a church in Sutherland Springs, the Associated Press reported. More than two dozen people were killed when a former U.S. airman opened fire during a church service. It was later determined that the gunman had been able to purchase firearms despite a criminal history. Three years earlier, while in the Air Force, he was convicted of assaulting an ex-wife and stepson, cracking the child's skull. He was discharged for bad conduct.

The Air Force had previously acknowledged it was remiss in not putting the felony conviction for domestic violence in into the FBI database, which could have prevented the shooter from buying guns from a licensed firearms dealer.

"No words or amount of money can diminish the immense tragedy of the mass shooting in Sutherland Springs," Vanita Gupta, associate attorney general for the Justice Department, said in a statement. "Today's announcement brings the litigation to a close, ending a painful chapter for the victims of this unthinkable crime."

found. Deputies said an argument started inside the home between the divorced couple.

Investigators believe the man was shot inside the home and collapsed outside on the lawn.

"They still cohabitate or live together, is what we are told. We don't know

what their living arrangements were," Gonzalez said in a news conference. "We'll have to determine exactly what happened, what led up to the shooting."

Although details are limited, the sheriff said this isn't the first time authorities had to check on the home. He said a previ-

ous call for service was issued before an arrest was made at that time, in a case unrelated to Sunday's deadly shooting, but they are working to clarify who was taken into custody.

Gonzalez said the woman was cooperating with authorities. It was not immediately known if she would face any charges.

your children may have.

"There's just no way of knowing what's going on in the heart unless you put it on the computer, which is basically what this ECG machine is," said Scott Stephens with the Cody Stephens Go Big or Go Home Foundation.

This heart screen was made possible through the hard work of that foundation, teen heart attack survivor Julieta Valdez, Harris County ESD 11, and KPRC 2.

"KPRC and Bill Spencer have been a wonderful God-send to us. Bill's very passionate about what we're doing, he understands the process, and he knows we're saving lives. We are so lucky to have KPRC on our team," Scott said.

Most of all, parents are grateful, to be able to get these expensive tests for their children absolutely free.

Romano brought his son Nick, a serious baseball player. "This is a great opportunity to prevent sudden cardiac arrest. He's [my son] an athlete. So we want to make sure we're taking every precaution to avoid something that really is preventable," Romano said.

Alexis Garza, a teen athlete, from Tomball saw KPRC's story promoting this heart screen and couldn't wait to come and get tested.

"I was like immediately, was like, 'Mom, I really want to go do this, just to make sure

everything is top tier with my heart and my health,'" Alexis said.

"I'm so thankful they gave us this opportunity. I probably wouldn't have done anything like this had this not been available to us," Romano said. Altogether, 278 student-athletes were tested.

Of those, medical professionals reported that they found 11 teens with heart ab-

normalities that will require follow-up with a cardiologist.

Five of those had significant heart problems, and three of them were found to have serious heart problems. Additionally, two of them had heart problems that appeared to be critical.

All of those kids were immediately referred to get the help they need.

# Walle & Democratic Legislators oppose TEA takeover of HISD

AUSTIN – After the TEA (Texas Education Commission) formally announced on Wednesday, March 15 that they planned on taking over control of Houston ISD and replacing its superintendent and installing a board of managers, Democratic Legislators led by Aldine's State Representative Armando Walle, Ron Reynolds and several others held a news conference to strongly oppose the move by TEA. Here is the statement that Walle issued:

"Neighbors, Today, the Texas Education Agency (TEA) announced they are initiating their takeover of the Houston Independent School District (HISD) by appointing a Board of Managers to govern the school district in lieu of the elected HISD School Board.

"For context, TEA notified HISD of their intent to appoint a Board of Managers and new superintendent in 2019, citing Texas law that authorizes a state takeover once a district demonstrates an inability to improve student achievement over time at

low-performing campuses. In response, HISD immediately sought a temporary injunction to prevent the takeover. In January of 2023, the Texas Supreme Court vacated this injunction, and it was formally dissolved on March 1, 2023.

"This morning, State Representatives and Senators of the Harris County Delegation met with Commissioner Mike Morath of the Texas Education Agency to discuss the takeover. During the meeting, many Members — including myself — expressed our disappointment and anger over the decision.

"Make no mistake — I do not support the state takeover of HISD. I believe Texans deserve the right to democratically elect board members to run our neighborhood schools. I acknowledge there's been underperformance in the past at some specific campuses, which can largely be tied to severe underfunding. However, I have voted against proposals in the Legislature year after year that, unfortunately, ultimately passed and have

led us to where we are now.

"I will continue to work with my colleagues in the Legislature to support proposals to prevent state takeovers of local ISDs. But those potential changes would be months away, and the HISD takeover is happening now.

"I pledge to work closely with our educators, administrators and the newly appointed Board of Members to support our community schools and ensure our students are receiving the best education possible.

I will be a loud advocate for every HISD student and their families to set our neighborhood schools up for success as this takeover is implemented, and speed up the return of our elected ISD board members.

At the end of the day, this is about our kids.

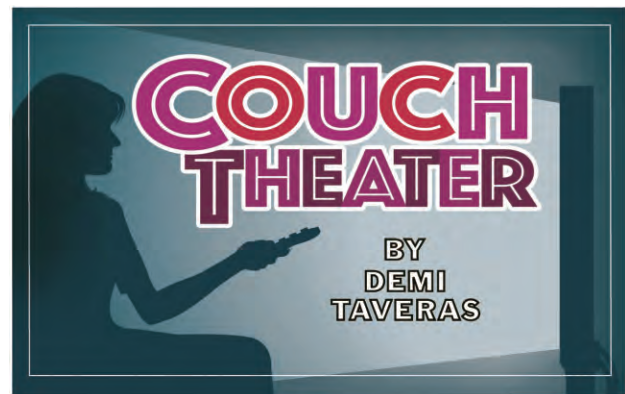

But, once Clare begins writing and speaking to her audience as if they were the 22-year-old version of herself, she finds powerful healing.

HOLLYWOOD — Jane Fonda, 85, finally fulfilled her wish to be a warrior queen when she voiced the Warrior Queen of the Seven Seas in the computer-animated, coming-of-age fantasy "Ruby Gillman: Teenage Kraken," due June 30. She'll first hit movie screens May 12 in "Book Club: The Next Chapter," with Diane Keaton, Candice Bergen and Mary Steenburgen. Hopefully, it will be more successful than "80 for Brady," which, despite having the star power of Fonda, Lily Tomlin, Sally Field, Rita Moreno and Tom Brady, cost \$28 million and grossed just under \$40 million.

\*\*\* Twenty-three years ago, "Gladiator" won Oscars for Best Picture, Best Actor (Russell Crowe), Best Visual Effects, Best Sound and Best Costume Design. Now, director Ridley Scott, 85, is finally making his sequel. This time, it'll star Irish actor Paul Mescal (who received an Oscar nomination for Best Actor this year for "Aftersun") and "Banshees Of Inisherin" Best Supporting Actor nominee Barry Keoghan. (Keoghan's up next in "Saltburn," with Rosamund Pike, Jacob Elordi and Carey Mulligan.) Add Denzel Washington (up next in "The Equalizer 3," due Sept. 1) to the mix, which will reteam him with Scott, his "American Gangster" director. You can also expect a Gladiator-style series that is currently in the works, starring Anthony Hopkins, and also a reboot of Starz's "Spartacus" series.

\*\*\* Russell Crowe is back with a vengeance, with "The Pope's Exorcist" (due April 14), co-starring Franco Nero. Crowe also has "Kraven the Hunter," with Aaron Taylor-Johnson and Ariana DeBose due October 6, as well as two films still awaiting release dates — first is "The Georgetown Project," with Sam Worthington, David Hyde Pierce and Karen Gillan. The second film is "Sleeping Dogs," also with Gillan, who will star as Nebula in the upcoming "Guardians of the Galaxy Vol. 3," releasing May 5.

\*\*\* Cheech & Chong were way ahead of their time when they made the pro-

marijuana film "Up in Smoke" (1978) for a mere \$2 million, which grossed a whopping \$104 million. Now 76, Cheech Marin has made about 80 films and starred in many TV series, including "Nash Bridges" (1996-2001). Tommy Chong, now 84, has made 21 films and about a hundred TV appearances. But now, the comedy duo are the subjects of an upcoming biopic. What could be more timely?

\*\*\* Before winning an Oscar for Best Actress for "Everything Everywhere All at Once," Michelle Yeoh was already the busiest actress in Hollywood. June 9 brings just her voice in "Transformers: Rise of the Beasts," while Sept. 15 brings "A Haunting in Venice," with Kenneth Branagh, Jamie Dornan and Tina Fey. Yeoh's also lending her voice to "The Tiger's Apprentice" and starring as Madame Morrible in "Wicked: Part One," due November 2024, and "Wicked: Part Two," due in 2025. Not to mention, she's already filmed "Avatar 3," releasing December 2024, and "Avatar 4," releasing December 2026. Even before she won her Oscar, she was already yo-yoing between multiple movie sets! 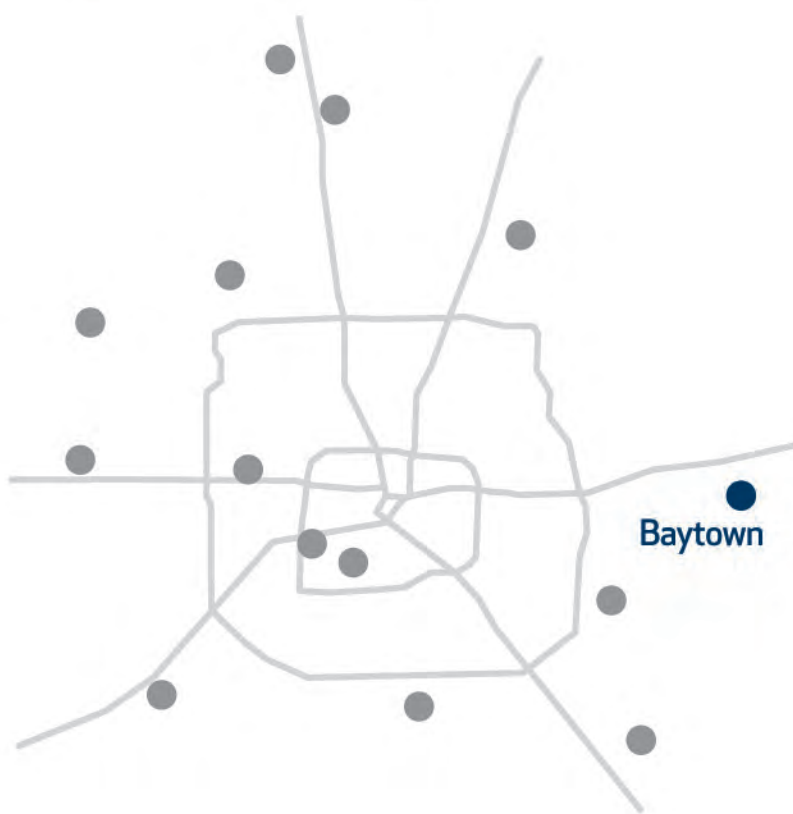
